**ADDENDUM TO  
MANAGEMENT AGREEMENT FOR  
ORANGEBROOK GOLF AND COUNTRY CLUB**

THIS ADDENDUM is made this 25 day of May, 2011, and amend the Agreement for Management of the Orangebrook Golf and Country Club dated the 23<sup>rd</sup> day of April, 2007, (hereinafter referred to as the "Agreement"), by and between JCD Golf of Florida, Inc., a Florida corporation, d/b/a JCD Sports Group" (hereinafter referred to as "Manager") and the City of Hollywood, (hereinafter referred to as the "City") as follows:

1. Section 3, Term, shall be revised as follows:


"Manager's engagement will be for a term of five (5) years commencing on October 1, 2011 ~~October 1, 2006~~ and ending on September 30, 2016 ~~September 30, 2011~~ except as otherwise provided in Section 26 below. ~~This agreement may be renewed for an additional five (5) year period under the same terms and conditions by written notification by JCD prior to June 30, 2011 and upon City Commission approval.~~

2. Section 20, Management Fee, shall be revised as follows:


~~"City shall pay to Manager, on or before the first day of each month, beginning October 1, 2006, a management fee equal to \$7,500.00 per month for the first year of the Agreement. The Management fee shall increase by 4% each October 1" of the subsequent four (4) years. A new management fee may be negotiated for any renewal term of the agreement. The management fee will be \$97,000 each year for the renewal period."~~
