A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, RATIFYING THE SUBMISSION OF AN APPLICATION TO THE BROWARD MARINE ADVISORY COMMITTEE TO RECEIVE THE 2023-2024 BROWARD BOATING IMPROVEMENT PROGRAM GRANT IN THE AMOUNT OF \$50,000.00; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ACCEPT THE GRANT, IF AWARDED, TO ASSIST WITH THE REMOVAL OF DERELICT VESSELS FROM THE WATERWAYS WITHIN THE CITY; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ALL GRANT DOCUMENTS.

WHEREAS, the Police Department submitted an application to the Broward Marine Advisory Committee for the 2023-2024 Broward County Boating Improvement Program ("BBIP") Grant to assist with the removal of derelict vessels from waterways within the City; and

WHEREAS, the grant will fund the removal of derelict vessels from the City's waterways; and

WHEREAS, the City desires to promote and enhance the safe and pleasurable use of the navigable waterways within the City; and

WHEREAS, if awarded, the acceptance of the grant does not require a contribution of matching funds and will incur no cost to the City's taxpayers; and

WHEREAS, it is understood that by the submission of the grant proposal, the City will abide by the terms and conditions set forth by the Broward County Marine Advisory Committee for use of the grant funds; and

WHEREAS, the Chief of Police recommends that the appropriate City officials accept, if awarded, the Broward Boating Improvement Program 2023-2024 grant funds from the Broward Marine Advisory Committee in the amount of \$50,000.00 for removing derelict vessels from City waterways.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the appropriate City officials to accept, if awarded, the 2023-2024 Broward Boating Improvement Program Grant in the amount of \$50,000.00.

<u>Section 3</u>: That the City Manager is authorized to accept the grant, if awarded, provided that the City Manager shall have the discretion to refuse the grant in those circumstances where he determines it is in the best interest of the City to do so, in which case he shall advise the City Commission of his intention to refuse the grant.

<u>Section 4</u>: That upon the Broward Boating Improvement Program grant funds being awarded to the City, and the City Manager accepting the award, appropriate City officials are authorized to execute all grant documents in a form acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

<u>Section 5</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
