A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED INTERLOCAL AGREEMENT BETWEEN THE CITY OF HOLLYWOOD AND THE CITY OF HOLLYWOOD COMMUNITY REDEVELOPMENT AGENCY (CRA) FOR COMMUNITY BUS AND TRANSIT SERVICES AND AUTHORIZING THE ESTABLISHMENT OF CERTAIN ACCOUNTS TO RECOGNIZE AND APPROPRIATE THE FUNDING RECEIVED BY THE CITY FROM THE BROWARD COUNTY COMMUNITY BUS SERVICE GRANT.

WHEREAS, the City of Hollywood (the "City") and the Hollywood CRA find that there is a need for public transportation services to serve a greater number of people traveling throughout the Downtown and Beach; and

WHEREAS, the City and Broward County (the "County") will enter into an Interlocal Agreement for Community Bus Service which Agreement takes effect on May 1, 2016 ("County Agreement"); and

WHEREAS, in accordance with the County Agreement, the City of Hollywood proposes contracting for the operation of a portion of the community bus system with the CRA wherein the City would provide the funds received from the County to the CRA to supplement the cost for the operation of the community bus system ("CRA Agreement") which is fully funded by the CRA; and

WHEREAS, the operation of the community bus system pursuant to both Agreements will be beneficial to citizens and visitors within the City of Hollywood; and

WHEREAS, both City and the CRA agree that better public transportation for residents of City and those persons traveling within or throughout City is needed; and

WHEREAS, it is desirable to provide expanded transit opportunities to the residents of the City, visitors and those persons traveling within or throughout the City; and

WHEREAS, it is the intent of the City that the additional forms of public transit provided shall not duplicate the existing mass transit provided by BCT; and

WHEREAS, the CRA Board, at its meeting of April 6, 2016, authorized the CRA Board Chair to execute an Interlocal Agreement for Community Bus and Transit Services:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1:</u> That it hereby approves and authorizes the execution, by the appropriate City Officials, of the attached Interlocal Agreement between the City of Hollywood and the City of Hollywood Community Redevelopment Agency for Community Bus and Transit Services, together with such non-material changes, if any, as may be acceptable to the City Manager and approved as to form and legality by the City Attorney.

<u>Section 2:</u> That it hereby authorizes the appropriate City Officials to establish certain accounts in order to recognize and appropriate the funding received by the City from the Broward County Community Bus Service Grant.

<u>Section 3:</u> That this resolution shall be in full force and effect immediately upon its passage and adoption.
