A RESOLUTION OF THE CITY COMMISSION OF THE CITY HOLLYWOOD. FLORIDA, **APPROVING** AUTHORIZING THE ALTERATION OF THE PARCEL **METHODOLOGY** APPORTIONMENT FOR NON-RESIDENTIAL STRUCTURES FROM UTILIZING RATES BASED ON SQUARE FOOT TIERS TO A RATE DEVELOPMENT METHODOLOGY BASED ON A PER-SQUARE-FOOT ASSESSMENTS, FOR FIRE RESCUE ASSESSMENT WITHIN THE CITY, AGAINST ASSESSED **PROPERTY** LOCATED WITHIN THE CITY OF HOLLYWOOD. FLORIDA FOR FISCAL YEARS BEGINNING WITH FY 2026 (OCTOBER 1, 2025) AND FORWARD.

WHEREAS, the City Commission has enacted Ordinance No. O-96-17 ("Ordinance"), which authorizes the imposition of Fire Rescue Assessments for fire rescue services, facilities, and programs against Assessed Property located within the City, and as further described in the Assessment Roll of the Assessed Properties; and

WHEREAS, the imposition of a Fire Rescue Assessment for fire rescue services, facilities, and programs each fiscal year is an equitable and efficient method of allocating and apportioning the assessed costs ("Fire Rescue Assessed Cost") among parcels of Assessed Property; and

WHEREAS, the City Commission desires to alter the parcel apportionment methodology for non-residential structures based on square foot tiers to a rate development methodology based on a per-square-foot, flat rate basis for the Fire Rescue Assessment within the City using the procedures provided by the Ordinance, including the tax bill collection method for fiscal years beginning with FY 2026 (October 1, 2025) and forward.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes altering the parcel apportionment methodology for non-residential structures based on square foot tiers to a rate development methodology based on a per-square-foot, flat rate basis for the Fire Rescue Assessment within the City using the procedures provided by the Ordinance, including the tax bill collection method for fiscal years beginning with FY 2026 (October 1, 2025) and forward, pursuant to the provisions of the Ordinance.
