A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A BLANKET PURCHASE AGREEMENT TO ENVIRONMENTAL PRODUCTS GROUP, INC. FOR TWO 2024 VACTOR MODEL 2100I SEWER CLEANER TRUCKS FOR AN AMOUNT NOT TO EXCEED \$1,114,861.90 BASED UPON SOURCEWELL CONTRACT #101221-VTR IN ACCORDANCE WITH SECTION 38.41(C)(5) OF THE PROCUREMENT CODE (PIGGYBACK); AMENDING THE FISCAL YEAR 2023 CAPITAL IMPROVEMENT PROGRAM.

WHEREAS, the Department of Public Utilities desires to purchase two Vactor sewer cleaner trucks for use in water distribution and stormwater soft digs, clearing blockages in main lines, wash downs, cleaning drains, manholes, and catch basins; and

WHEREAS, the desired Vactor sewer cleaner trucks were competitively bid by Sourcewell, a government cooperative, and approved and awarded to Environmental Products Group, Inc. ("EPG") on December 26, 2021, via contract #101221-VTR for Sewer Vacuum, Hydro-Excavation, and Municipal Pumping Equipment with Related Accessories and Supplies; and

WHEREAS, the current term of the Sourcewell contract #101221-VTR is from December 26, 2021 through November 29, 2025; and

WHEREAS, EPG has agreed to extend to the City the same pricing under the terms and conditions set forth in Sourcewell contract #101221-VTR; and

WHEREAS, the period of performance during which the desired two Vactor sewer cleaning trucks will be acquired is from December 26, 2021 through November 29, 2025, for an amount not to exceed \$1,114,861.90; and

WHEREAS, Section 38.41(C)(5) of the Procurement Code allows the Chief Procurement Officer to procure, without formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof ("piggyback"), provided that the goods, supplies, materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference and such utilization of other governmental entities contracts shall be permitted only during the term of the other governmental entity's contract; and

WHEREAS, the Director of the Department of Public Utilities and Chief Procurement Officer recommend that the City Commission approve and authorize the execution of a Blanket Purchase Agreement to Environmental Products Group for two Vactor sewer cleaning trucks in an amount not to exceed \$1,114,861.90; and

WHEREAS, the FY 2023 Capital Improvement Plan was adopted and approved by the City Commission pursuant to Resolution R-2022-284 at the Second Public Budget Hearing on September 22, 2022; and

WHEREAS, partial funding for this purchase was included in the amended FY 2023 Capital Improvement Plan and is available in account numbers 441.409904.53600.564530.001642.000.000 and 443.419901.53800.564530.001641.000.000; and

WHEREAS, it is necessary to amend the approved FY 2023 Capital Improvement Plan as set forth in the attached Exhibits "1" and "2".

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of a Blanket Purchase Agreement with Environmental Products Group, Inc., together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That these Amendments to the FY 2023 Capital Improvement Plan for the Fiscal Year beginning October 1, 2022 and set forth in detail in the attached Exhibits "1" and "2" are adopted and authorized as Amendments and/or Adjustments to the Operating Budget and Capital Improvement Plan of the City of Hollywood, Florida, for the Fiscal Year 2023.

Section 4: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
