A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING RESOLUTION R-2016-016 TO CHANGE THE DATE OF CITIZENS' COMMENTS FROM NOVEMBER 22, 2016, TO NOVEMBER 2, 2016, AND TO CHANGE THE STARTING TIME OF THE NOVEMBER 22, 2016 REGULAR COMMISSION MEETING TO 11:00 AM.

WHEREAS, Section 2.04 of the Charter of the City of Hollywood provides, in relevant part, that the City Commission shall meet regularly not less than 20 times during the calendar year, at such times and places as shall be specified by Resolution; and

WHEREAS, pursuant to a series of resolutions, the City Commission has adopted its regular meeting schedule as the first and third Wednesdays of each month starting at 1:00 PM, except during the month of August; and

WHEREAS, the City Commission passed Resolution R-2016-016 which changed the regularly scheduled Wednesday, November 16, 2016, meeting to Tuesday, November 22, 2016, starting at 9:00 AM, with citizens' comments at 5:00 PM; and

WHEREAS, the City Commission desires to move Citizens' Comments from the November 22, 2016, Commission meeting to the November 2, 2016, Commission meeting at 5:00 PM; and

WHEREAS, the City Commission desires to amend Resolution R-2016-016 to change the starting time of the Tuesday, November 22, 2016, Commission meeting from 9:00 AM to 11:00 AM; and

WHEREAS, the schedule changes to the November 22, 2016, meeting will allow the newly elected officials to be sworn into office;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the first regular meeting of the Hollywood City Commission scheduled on November 2, 2016, will have citizen's comments at 5:00 PM.

Section 2: That the second regular meeting of the Hollywood City Commission scheduled on Tuesday, November 22, 2016, will start at 11:00 AM, with no citizens' comments.

RESOLUTION CHANGING THE NOVEMBER 2016 COMMISSION MEETINGS.

Section 3: Thereafter, regular meetings of the City Commission shall, unless otherwise provided by Resolution, be held on the first and third Wednesdays of each month.

Section 4: That this resolution shall be in full force and effect immediately upon its passage and adoption.
