RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING THE ATTACHED DESIGN DEVELOPMENT PLANS FOR THE HOLLYWOOD BOULEVARD ROADWAY CORRIDOR BETWEEN DIXIE HIGHWAY AND CITY HALL CIRCLE, AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS ΤO SUBMIT THE APPROVED DESIGN DEVELOPMENT PLANS TO BROWARD METROPOLITAN PLANNING ORGANIZATION (BROWARD MPO) AND THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) TO BEGIN FINAL CONSTRUCTION DRAWINGS AND PROJECT IMPLEMENTATION THROUGH THE \$6,800,000.00 COMPLETE STREETS FUNDING FROM BROWARD MPO; AND PROVIDING FUTURE FUNDING, SUBJECT TO THE ADOPTION AND APPROVAL OF THE FY 2016 – FY 2020 CAPITAL IMPROVEMENT PLAN, IN THE ESTIMATED AMOUNT OF \$600,000.00 TO IMPLEMENT THE LANDSCAPE, IRRIGATION, AND SITE FURNISHING ELEMENTS OF THE PROJECT.

WHEREAS, the Broward Metropolitan Planning Organization (Broward MPO), has funding available from Federal and State sources to promote their "Complete Streets" program; and

WHEREAS, the Broward MPO awarded the City of Hollywood approximately \$6,800,000.00 within their transportation Improvement Program to fund a Complete Streets project on Hollywood Boulevard between City Hall Circle and Dixie Highway; and

WHEREAS, the City of Hollywood presently maintains this section of Hollywood Boulevard and would continue to do so once the improvements are in place; and

WHEREAS, the Department of Public Works desires to move forward with the implementation of the "Complete Streets" conceptual plans as more specifically depicted in Exhibit "A" attached hereto and incorporated herein by reference; and

WHEREAS, the Department of Public Works exercised due diligence in community outreach through two open community presentations and individual outreach to building and/or business owners directly along the aforementioned segment of the corridor, and received positive support for the conceptual design; and

WHEREAS, the Broward MPO project funding of \$6,800,000.00 is earmarked for the design and construction of all the hardscape elements to include the paving, grading, drainage, lighting, signalization, walkways, signage and pavement marking elements of the project; and WHEREAS, project elements not funded by Broward MPO include landscaping, irrigation and site furnishings which are estimated to be at a project cost of \$600,000, which the City is expected to implement and fund as part of its share in the Complete Streets Project; and

WHEREAS, the next step for implementation of this project requires submittal of design development plans to the Broward MPO and FDOT for the preparation and completion of final Construction Drawings for the construction phase of the project which includes but is not limited to grading, drainage, roadways, walks, for an estimated project cost of \$6,800,000.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That it hereby authorizes the appropriate City Officials to transmit the conceptual design development documents for the Hollywood Boulevard Complete Streets project between City Hall Circle and Dixie Highway, as more specifically depicted in Exhibit "A" attached hereto and incorporated herein by reference, to the Broward MPO and FDOT to prepare the final Construction Drawings.

<u>Section 2</u>: That it hereby approves funding for the landscaping, irrigation and site furnishings for the project, subject to the adoption and approval of the FY2016 – FY 2020 Capital Improvement Program, in the estimated amount of \$600,000.00.

<u>Section 3</u>: That this resolution shall be in full force and effect immediately upon its passage and adoption.
