I. STATEMENT OF THE AGENCY'S PURPOSE

The Broward Center for the Performing Arts (Broward Center) presents an average of more than 700 events to more than 600,000 community members each year and contributes more than \$130 million annually in local economic impact. Artistic presentations span multiple venues throughout the county and range from the best of Broadway to award-winning local and international cultural programming, including South Florida's own Miami City Ballet, Florida Grand Opera, Gold Coast Jazz Society and Symphony of the Americas. The Broward Center also has the largest free arts-in-education program in the country, through which more than 3.5 million Broward County students to date have attended and participated in educational and cultural performances free of charge.

II. STATEMENT OF THE AGENCY'S MISSION

The Broward Center builds community through the arts by delivering quality entertainment, educational opportunities and memorable moments that engage and inspire audiences, nurture collaboration and drive economic vitality.

III. PROGRAM/PROJECT DESCRIPTION:

The Broward Center requests City of Hollywood funding to support the Student Enrichment through the Arts (SEAS) program for the 2024 academic year, which will serve a minimum of 6,000 Hollywood public school students through cultural arts enrichment activities tied to STEAM-focused classroom curriculum that will increase potential for academic success. From October to May, students will have the opportunity to experience high-quality, professional performances at no charge that reinforce reading, math and science skills, bring historical events to life and immerse students in different cultures. All SEAS shows are directly aligned with Florida B.E.S.T. standards and include a curriculum-aligned study guide. The 2024 season will also focus on presenting artists of color and shows that promote themes of diversity, equity and inclusion. While exact artists for 2024 have yet to be confirmed, recent SEAS seasons have included shows such as HAMILTON, To Kill A Mockingbird, Commanding Space, Alvin Ailey Dance Company, Step Afrika!, Midsummer Night's Dream, Bill Blagg: The Science of Magic, and much more. Select shows will also include SEAS Plus workshops led by teaching artists that build on



educational content from the performance through interactive, arts-based activities. "Sensory-inclusive" shows and corresponding activities will also be offered to ensure students with autism or other developmental disabilities have the same learning opportunities as their peers. After each show, teachers will be provided with resources to lead students in discussions and projects that help apply what was experienced in the theater to real-world math, science and reading situations.

IV. PROGRAM/PROJECT NEEDS AND OBJECTIVES:

Research demonstrates that students with access to the arts in or out of school are more engaged in life and tend to have better academic results, lower dropout rates, better workforce opportunities and more civic engagement. According to the Americans for the Arts, a student engaged in the arts is four times more likely to be recognized for academic achievement, four times more likely to participate in a math or science fair, three times more likely to win an award for school attendance and three times as likely to be elected to class office. In particular, research has shown that students from low-income families who have arts-rich experiences are more likely to achieve key positive outcomes than their peers without access to the arts. Unfortunately, many Broward public schools, particularly those in low socioeconomic areas, still lack the resources to offer art classes, field trips for cultural enrichment activities and arts-integrated teaching of STEM subjects. The SEAS program annually brings more than 6,000 Hollywood students, primarily from Title-I schools, to see educational performances at the Broward Center free-of-charge, helping to ensure as many students as possible have access to the educational power of the arts regardless of socioeconomic status. By connecting the performing arts directly with classroom curriculum, SEAS helps bring reading, math, science and history alive and engages students with arts-based learning techniques that will help them be successful in school and in life.



V. ANTICIPATED OUTCOMES:

a. Describe the anticipated outcomes as the result of this program / project (150 word maximum).

The Broward Center's SEAS program will provide a significant benefit to a minimum of 6,000 Hollywood students, the majority of whom attend Title 1 schools and come from low-to-moderate income households, by educating, engaging and inspiring them to reach their academic potential while at the same time fostering self-confidence, creativity and appreciation for the arts. By transforming the theater into an extended classroom, the SEAS program will provide new ways of reaching children who may not be adequately served through traditional teaching methods. Live theater experiences actively engage students both visually and intellectually, and when students are engaged, learning takes place in the most effective way. Additionally, the SEAS program will provide Hollywood public school teachers with the opportunity and resources to use the arts as a tool to complement their lesson plans, helping them make the connection between theater performances and engaged learning classroom activities.

With support from the City of Hollywood, the SEAS program served 6,856 students and teachers from Hollywood during FY 2022 through a combination of virtual and in-person activities tied directly to reading, science, math and civics curriculum. Show titles and curriculum connections included Traditions of Chinese Acrobatics (Dance, Social Studies, Foreign Language, Physical Education, Theatre), Tango Fire (Social Studies, Dance), A Midsummer Night's Dream (ELA, Social Studies, Theatre), The World Turned Upside Down: Stories and Songs of the American Revolution (Social Studies, Music, Theatre), Once on This Island (Theatre, Social Studies, Language Arts, Dance), I Have a Dream (Social Studies), Pirate School: Follow Your Compass (Social / Emotional Learning), Commanding Space: The Rise of Annie Easley and the Centaur Rocket (STEM, Social Studies), The Playmakers Tour (Humanities, Language Arts), Kuniko Yamamoto – Japanese Storytelling (Math, Social Studies), Stories and Songs in the Oral Tradition (Language Arts, Music, Social Studies), Matilda (Language Arts, Social Studies, Theatre), She Persisted (Social Studies, Theatre), The



Cat in the Hat (Language Arts), Dr. Kaboom's Look Out, Science is Coming! (STEM) and The Singing Zoologist (STEM). In post-performance surveys distributed to participating teachers, all information received by the Hollywood participants was positive, with teachers commenting on how the program helped supplement the curriculum they were teaching in the classroom.

The SEAS program continues to serve Hollywood residents in FY 2023, with 1,981 students and teachers from Hollywood schools served already during the first quarter.

VII. COMMUNITY COLLABORATIONS AND PARTNERS:

The Broward Center's long-standing partnership with the School Board of Broward County has helped ensure more than 30 years of success with SEAS and its growth to become the largest program of its kind in the country. Each year the School Board assesses the educational value of the performances the Broward Center has proposed for the upcoming season and ensures that activities are aligned with school curriculum goals and Florida Core Curriculum state standards. The School Board employs a dedicated SEAS coordinator to manage registration, attendance, outcome measurement and the transportation of students to performances. The School Board also provides bus transportation for classes to attend performances. The Broward Center engages approximately 80 volunteers annually to serve as SEAS ushers, who play an important role in providing a meaningful theater experience by ensuring all students are safely guided around the campus as they move from busses to theater to classroom.
