I have been a board member of the North Central Hollywood Civic Association (NCHCA) since 2013. I serve as ambassador-at-large to the greater Hollywood community. Since January, 2016, I have been the NCHCA representative to the Hollywood Council of Civic Associations.

As an active member of the Board of Directors of the NCHCA my activities reflect my belief that what affects one neighborhood affects us all; that we need to work together for a better, more livable Hollywood; and that the road to a revitalized City will only be accomplished through strengthening community relationships among residents across the city. I also believe that having fun together should be an important aspect of community building.

As a volunteer member of the first and second annual Hollywood Council of Civic Associations "Be Mine" Dog Show committee, I worked to make it a success. I put in many hours handing out flyers, reaching out to businesses and other sponsors, utilizing social media, and making significant contributions to planning the event, not to mention my outreach to Pete Brewer's family and my work the day of the show. Important as well, it was fun.

I have supported the goals of the Hollywood Green Team Advisory Committee and the City's Green building ordinance. I regularly attend the committee's meetings and share what I learn with a growing network of community members. My concern about sea level rise and the challenges we face on our coast as well as from salt water intrusion led me to enroll and complete the first of three core courses in the Florida Master Naturalist Program offered through the University of Florida's adult education program.

It was a 40-hour program that through classroom, field trip, and practical experience provided instruction on the general ecology, habitats, vegetation types, wildlife, and conservation issues of Coastal

Systems in Florida including Coastal Uplands, Estuarine, and Nearshore Marine Environments. The program also addressed society's role in coastal areas, developed naturalist interpretation skills, and discussed environmental ethics. I brought that knowledge back to Hollywood for our use. This was the first university level course I ever took and in spite of my challenges with asthma, I attended every class and completed the course. I now have a knowledge base that is valuable and available to our community.

I was an active participant Hollywood's team in the 39th Broward County Waterway Cleanup that was held last spring on Saturday March 5th. My environmental activities also have included participating in the City's first Tree Workshop in April 2016, coordinated by the City's new part-time Environmental Sustainability Coordinator, Lindsay Nieratka. It was a hands-on workshop that taught participants about the challenges to our City's trees, resources to enhance tree canopy, new online tools and hands-on practical skills to enhance yards and streetscapes. I participated in Hollywood Gardens West's Arbor Day tree planting last year to support the efforts of all those involved.

As a member of NCHCA, I volunteered to be on the ad hoc committee to Save Sunset Golf Course. I distributed flyers in the Community to raise awareness of a potential development for residences on the site. I played a major role in distributing the "Save Sunset Golf Course" yard signs to thousands of residences in every district in the city.

As a committee member, I helped plan and participate in the Community Town Hall Meeting for Sunset Golf Course held at the Rotary Club, March 13, 2014. I worked with other committee members in promoting the "Sunset at Sunset" block party event where Hollywood residents and officials were invited to stroll down Arthur

Street, meet the homeowners, and get the true feel of a 45-acre open green space and its wildlife at sunset.

In May and June of 2014, I participated for five weekends in the Yellow Green Market educational booth to promote awareness of the threat to this large green space, and to educate residents on the importance of who is elected to the city commission.

To that end, I assisted residents in locating the district in which they reside using a large-scale model of the City Districts Map, and collecting "Keep Sunset Green" postcards. The Save Sunset Golf Course postcard campaign kept me very busy. I hand delivered hundreds of postcards to the Mayor and Commissioners' offices at City Hall. The cards came from residents stating they wanted the Mayor and their respective commissioners to keep Sunset Golf Course green.

I am one of the founding Directors of Friends of Hollywood Florida Inc., a 501 (c) 3 incorporated in 2014, dedicated to educating the public on environmental related issues. (Mission Statement attached). I participated in creating the detailed proposal "Sunset Golf Course a Public Utility". This was delivered to the Mayor, Commissioners, and the City Manager in March 2015. The proposal sets forth the grounds for the City to purchase the property, and the funding source for the purchase. To date, the efforts to keep Sunset Golf Course undeveloped have succeeded.

Charles F. Vollman Park Design: I was an active member of the resident-organized NCHCA committee to work with Ram Development on the design for the new City Park at the old Okomo Trailer Park on Taft Street. That committee's efforts in working with the developer and city staff kept the park from becoming nothing more than a grand

entrance to the new rental community. That project is completed and one only needs to drive past it on Taft Street to see the great results: a grand cathedral of Live Oak trees with places for residents to enjoy the majesty of those trees and the history of the Coral House located within the park.

I volunteered in the NCHCA's booth in Party on the "J" in 2014 educating residents on the threat to Sunset Golf Course, and volunteered again in 2015, 2016 and 2017 to support the NCHCA and its projects.

I am involved in Regional Issues that affect Hollywood:

Sea Level Rise - I attended the workshops: The Planning for Sea Level Rise and Storm Surge: Modelling Cost for Sea Level Rise and Benefits for Coastal Broward County, in 2015 and am the NCHCA's liaison on this issue.

In 2014 I volunteered outside the polls during early voting in the general election for 21 days distributing literature in support of Amendment #1, the Florida Water and Land Conservation Initiative.

I volunteered at the polls during the August primary in 2016 to promote Amendment #4, on the State ballot, to allow proliferation of privately owned solar.

I volunteered for 21 days at the polls during the general election in 2016 to defeat the FP&L backed solar amendment #1.

CITY MEETINGS I have attended almost every Planning and Development Board meeting, Green Team Advisory Committee meetings, City of Hollywood Commission meetings and workshops, all Commission in the Community meetings, Technical Advisory Committee meetings, and have, during citizen comments, challenged the city

commission to remember and embrace the vision Joseph Young had for the City of Hollywood.

I have attended MPO -Complete Streets committee meetings.

I have attended County Commission meetings and meetings for Broward NEXT, and Climate Change task force meeting.

I am a member of the Hollywood Hills and the United Neighbors Civic Associations. I attend other Civic Association Meetings and participate in community-building events with the goal of building stronger ties and alliances between neighborhoods.

I have participated in Broward Waterway Clean-Up 2015 and 2016. I participated in the Hollywood Historical Society's Downtown walking tour as an ambassador, Ground Breaking for Complete Streets, Ground Breaking for 441 and Hollywood Blvd; and update meetings
