

RESOLUTION NO. R-2023-379

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AUTHORIZATIONS TO PROCEED WITH ATKINSREALIS USA, INC., D/B/A ATKINS NORTH AMERICA, INC., TO PROVIDE PROFESSIONAL ENGINEERING CONSULTING SERVICES FOR PHASE 3 OF THE TRAFFIC CALMING PROGRAM FOR UP TO \$114,986.00 AND A LANE REPURPOSING STUDY ALONG WEST PARK ROAD FOR UP TO \$20,000.00, AND TO EXTEND THE PROFESSIONAL SERVICES AGREEMENT FOR AN ADDITIONAL ONE YEAR PERIOD.

WHEREAS, AtkinsRealis USA, Inc., d/b/a Atkins North America, Inc. ("Atkins"), currently has a continuing Professional Services Agreement ("Agreement") for civil, landscape, architecture, planning, and engineering services for future roadway and complete streets projects, which was approved by the City Commission on December 19, 2018, pursuant to Resolution No. 2018-400; and

WHEREAS, on March 4, 2020, the City Commission passed and adopted Resolution No. R-2020-56 authorizing appropriate City officials to issue an Authorization to Proceed to Atkins to provide professional engineering services for the establishment of a Traffic Calming Program ("Program") to address safety concerns raised by residents regarding vehicular speeding and cut-through traffic in their neighborhoods; and

WHEREAS, Atkins completed the initial scope of work under Phases 1 and 2 to study and prioritize the proposed locations for various traffic calming elements Citywide, which is to be included in the preparation of conceptual plans for construction; and

WHEREAS, the Division of Engineering, Transportation and Mobility ("Division") has determined that additional professional engineering services are needed to develop the next phase ("Phase 3") of the Program that would focus on the preparation of traffic calming studies and conceptual plans for construction; and

WHEREAS, Division staff requested and negotiated proposals from Atkins to provide professional engineering services to facilitate Phase 3 of the Program and for an additional lane repurposing study on West Park Road; and

WHEREAS, the Agreement with Atkins will expire on February 13, 2024, and therefore, an extension of the Agreement is requested for an additional one year to allow sufficient time to complete both projects; and

WHEREAS, funding for Phase 3 of the Traffic Calming Program was included in the amended FY 2024 Capital Improvement Plan, and is available in account number 333.149901.54100.563010.001185.000.000; and

WHEREAS, funding for the lane repurposing study is available in account number 001.140202.51500.531300.000000.000.000; and

WHEREAS, the Director of Development Services and the City Engineer recommend that the City Commission approve and authorize the appropriate City officials to execute Authorizations to Proceed with Atkins for Phase 3 of the Traffic Calming Program for up to \$114,986.00 and a lane repurposing study on West Park Road for up to \$20,000.00 as outlined in the Atkins proposals, for a combined amount not to exceed \$134,986.00, and authorize the extension of the Agreement with Atkins for an additional one year.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and incorporated in this Resolution.

Section 2: That it approves and authorizes the execution and issuance, by appropriate City officials, of the attached Authorizations to Proceed and extension of the Agreement with Atkins for an additional one year, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.



