WHEREAS, the Agreement provides for the establishment of a Governing Board comprised of elected officials from Broward County, and each party must appoint one of its elected officials and one alternate member to serve as a representative on the Governing Board; and

WHEREAS, the representative must attend all meetings of the Authority Governing Board and if selected to serve on the Executive Committee, attend all Executive Committee meetings, vote on Authority business on behalf of the City, and communicate Authority business/actions to the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.
