

RESOLUTION NO. R-CRA-2022-51

A RESOLUTION OF THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY ("CRA"), RANKING CONSTRUCTION MANAGEMENT AT RISK FIRMS AND AUTHORIZING THE APPROPRIATE CRA OFFICIALS TO NEGOTIATE PHASE I PRECONSTRUCTION SERVICES WITH THE HIGHEST RANKED FIRM, BURKHARDT CONSTRUCTION, INC., TO PROVIDE CONSTRUCTION MANAGEMENT AT RISK FOR PHASE IV - UNDERGROUNDING OF OVERHEAD UTILITIES AND STREETScape BEAUTIFICATION AT EW STREETS, STREETENDS, SURF ROAD FROM HARRISON STREET TO MAGNOLIA TERRACE AND SR A1A FROM HOLLYWOOD BOULEVARD TO THE SOUTHERN CITY LIMITS PROJECT.

WHEREAS, it is in the best interest of the Hollywood Community Redevelopment Agency ("CRA") to enter into an agreement with a qualified general contractor to provide professional Construction Management at Risk Services for the Phase IV Undergrounding of Overhead Utilities and Streetscape Beautification Project; and

WHEREAS, in accordance with Section 255.103, Florida Statutes entitled "Construction Management Entities", the CRA has followed the procedures set forth in Section 287.055, Florida Statutes entitled "Consultants' Competitive Negotiation Act" ("CCNA") and the City's Procurement Code to advertise for Statements of Qualifications for Construction Management at Risk Services; and

WHEREAS, on June 15, 2022, Request for Qualification ("RFQ") Number RFQ-4736-22-GJ was electronically advertised on www.BidSync.com to solicit the desired firms to provide Construction Management at Risk Services, attached as Exhibit "A"; and

WHEREAS, prior to the initial deadline, the Office of the City Clerk only received one response to the Statement of Qualifications; and

WHEREAS, on July 20, 2022, the City's Procurement Department issued an addendum to extend the RFQ submittal deadline from July 20, 2022 to August 17, 2022; and;

WHEREAS, on August 17, 2022, the Office of the City Clerk received Statements of Qualifications packages from two Construction Management at Risk firms, attached as Exhibit “B” and Exhibit “C”:

1. Burkhardt Construction, Inc.
2. The Whiting-Turner Contracting Company; and

WHEREAS, as part of the process to determine qualifications, a Selection Committee consisting of four professional in-house staff were invited to review and evaluate the Statements of Qualifications, attached as Exhibit "D"; and

WHEREAS, on September 6, 2022, the Selection Committee met virtually to evaluate and rank the Statements of Qualifications based upon the Evaluation Criteria established in the RFQ, and the Selection Committee determined that oral presentations were not needed to rank the firms; and

WHEREAS, based on the Evaluation Criteria, the Selection Committee evaluated the two proposals and the scores were compiled to arrive at the following rankings, with the highest score being the highest ranked, attached as Exhibit “E”:

Burkhardt Construction, Inc.	(396 points)
The Whiting-Turner Contracting Company	(367 points)

; and

WHEREAS, Section 287.0554(b), Florida Statutes, requires that a minimum of three firms be selected; and

WHEREAS, the CRA has made good faith efforts to obtain a minimum of three firms but was unable to do so despite two attempts at advertising the services that are desired; and

WHEREAS, the CRA recommends that the CRA Board authorize the appropriate CRA officials to negotiate the Construction Management at Risk Agreements, as included in the Request for Qualifications package, attached as Exhibit “A”, with the highest-ranked firm to provide Construction Management at Risk services as set forth above; and

WHEREAS, upon negotiating the Phase I Pre-Construction Services Agreement with the highest rank firm, if the contract amount falls within the CRA Executive Director’s authority pursuant to Section 38.38 of the City’s Procurement Code, the CRA Executive Director will execute the agreement, but if the contract amount exceeds his

authority, the agreement will be brought back to the CRA Board for consideration at a later date; and

WHEREAS, after execution of the Phase I Pre-Construction Services Agreement, the parties will negotiate the Phase II Construction Services Agreement for consideration by the CRA Board at a later date; and

WHEREAS, funding for this project was included in the adopted Fiscal Year 2023 budget; and

WHEREAS, funds for the preconstruction services portion of this project are available in account number 163.639901.552.563010.001236.000.000 and account number 163.639901.552.563010.001235.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY:

Section 1: That the foregoing “WHEREAS” clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it authorizes the appropriate CRA officials to negotiate a Phase I Pre-Construction Services Agreement with the highest ranked firm, Burkhardt Construction, Inc., together with such non-material changes as may be subsequently agreed to by the CRA Executive Director and approved as to form and legal sufficiency by the CRA’s General Counsel.

Section 3: That if the negotiated Phase I Pre-Construction Services amount falls within the CRA Executive Director’s authority pursuant to Section 38.38 of the City’s Procurement Code, the CRA Executive Director is authorized to execute the Agreement.

Section 4: That in the event that the contract amount is above the CRA Executive Director’s authority, the Agreement will be brought back to the CRA Board at a later date for consideration and approval.

Section 5: That if the appropriate CRA officials are unable to negotiate an agreement with the highest-ranked firm, then they are authorized to terminate negotiations with that firm and commence negotiations with the next highest-ranked firm and execute an agreement, if possible, in accordance with Section 3.

Section 6: That this Resolution shall be in full force and effect immediately upon its passage and adoption.

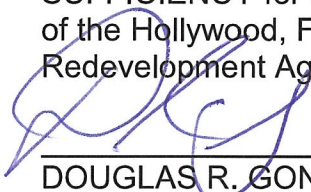
