A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED 2014 AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN THE CITY OF HOLLYWOOD AND BROWARD COUNTY REGARDING THE LOCAL OPTION GAS TAX, THE ATTACHED 2014 AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN THE CITY OF HOLLYWOOD AND BROWARD COUNTY REGARDING ADDITIONAL LOCAL OPTION GAS TAX ON MOTOR FUEL, AND THE ATTACHED 2014 AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN THE CITY OF HOLLYWOOD AND BROWARD COUNTY REGARDING ADDITIONAL LOCAL OPTION GAS TAX ON MOTOR FUEL FOR TRANSIT.

WHEREAS, Broward County has adopted by Ordinance a Local Option Gas Tax, an additional Tax on Motor Fuel, and an additional Tax on Motor Fuel for Transit; and

WHEREAS, a portion of the funds collected is shared with units of local government within Broward County based on population; and

WHEREAS, each year amendments to the Interlocal Agreements (ILA) between Broward County and Hollywood need to be approved amending the distribution of funds as the county population changes; and

WHEREAS, in the 2014 Amendment to the ILA providing for the division and distribution of the proceeds from the Local Option Gas Tax, the distribution to Broward County is 62.5% and the amount distributed among the Cities based on population is 37.5%; and

WHEREAS, in the 2014 Amendment to the ILA providing for the division and distribution of the proceeds from the additional Local Option Gas Tax on Motor Fuel, the distribution to Broward County is 48.73% and the amount distributed among the Cities based on population is 51.27%; and

WHEREAS, in the 2014 Amendment to the ILA providing for the division and distribution of the proceeds from the additional Local Option Gas Tax on Motor Fuel for Transit, the distribution to Broward County is 48% and the amount distributed among the Cities based on population is 26%, with the remaining 26% being distributed to eligible municipalities by grant agreement for community shuttle services; and

WHEREAS, the current method of distribution is inequitable because it takes only residents into consideration, not the actual usage of roadways by travelers working in and visiting the City; and

WHEREAS, the distribution of Local Option Gas Taxes should be re-evaluated to accurately reflect usage of city streets, number of collector miles, and cost of maintenance; and

WHEREAS, the Director of Financial Services and the City Attorney have reviewed the 2014 Amendment to the Interlocal Agreement between Broward County and the City of Hollywood regarding the Local Option Gas Tax, the 2014 Amendment to the Interlocal Agreement between Broward County and the City of Hollywood regarding the Additional Tax on Motor Fuel, and the 2014 Amendment to the Interlocal Agreement between Broward County and the City of Hollywood regarding the Additional Tax on Motor Fuel for Transit;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the execution, by the appropriate City officials, of the attached 2014 Amendment to the Interlocal Agreement between the City of Hollywood and Broward County, providing for the division and distribution of the proceeds of the Local Option Gas Tax imposed by the Broward County Local Option Gas Tax Ordinance, the attached 2014 Amendment to the Interlocal Agreement between the City of Hollywood and Broward County, providing for the division and distribution of the proceeds of the Additional Tax on Motor Fuel, and the attached 2014 Amendment to the Interlocal Agreement between the City of Hollywood and Broward County of Hollywood and Broward County providing for the division and distribution of the proceeds of the proceeds of the proceeds of the City of Hollywood and Broward County providing for the division and distribution of the proceeds of the Local Gas Tax on Motor Fuel for Transit, together with such nonmaterial changes as may be agreed to by the City Manager and approved as to form and legality by the City Attorney.

<u>Section 2</u>: That the City of Hollywood recommends that the distribution of Local Option Gas Taxes be re-evaluated to accurately reflect usage of city streets, number of collector miles, and cost of maintenance.
