A RESOLUTION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF AN INTERLOCAL AGREEMENT WITH BROWARD COUNTY FOR AIRPORT ZONING REGULATIONS.

WHEREAS, Broward County owns and operates the Fort Lauderdale-Hollywood International Airport and North Perry Airport, located in Broward County, Florida; and

WHEREAS, a portion of the airport hazard area, as defined in Section 333.01(4), Florida Statutes ("Airport Hazard Area"), is located within the municipal limits of the City of Hollywood; and

WHEREAS, City and County are required by Section 333.03(1)(b), Florida Statutes, to either enter into an interlocal agreement or create a joint airport zoning board to administer and enforce airport zoning regulations, as specified in Section 5-182.10 of the Broward County Code of Ordinances ("Airport Zoning Regulations"); and

WHEREAS, the City and County desire to enter into this Agreement to administer and enforce Airport Zoning Regulations in the Broward County Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

- <u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.
- <u>Section 2</u>: That it approves and authorizes the City to enter into the Interlocal Agreement with Broward County for the administration and enforcement of Airport Zoning Regulations.
- <u>Section 3</u>: That the Mayor or City Manager is authorized and directed to execute the Interlocal Agreement on behalf of the City and to take any further actions necessary to implement the terms and conditions of the Agreement.
- <u>Section 4</u>: That the City and County affirm their commitment to cooperate in the administration and enforcement of Airport Zoning Regulations, promoting safe and efficient use of the airspace within the Airport Hazard Area.
