A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A PARKLET REVOCABLE LICENSE AGREEMENT WITH GO BISTRO FOR THE PLACEMENT OF A PARKLET SEATING AREA ADJACENT TO THE PROPERTY LOCATED AT 2035 HOLLYWOOD BOULEVARD WITHIN THE PUBLIC RIGHT-OF-WAY METERED PARKING SPACES, IN THE AMOUNT OF \$2,880.00.

WHEREAS, Go Bistro is the owner of the restaurant located at 2035 Hollywood Boulevard; and

WHEREAS, on October 4, 2017, the CRA Board passed and adopted Resolution No. R-CRA-2017-40, which directed CRA staff to implement a Parklet Pilot Program for a one year period in the Downtown CRA; and

WHEREAS, on September 5, 2018, the CRA Board passed and adopted Resolution No. R-CRA-2018-30, which set the rate and time frame for the Parklet Pilot Program; and

WHEREAS, the attached parklet revocable license agreement reflects a six month term and lost revenue recovery fee of \$8.00 a day per parking meter, and contains the required liability insurance coverage and indemnification for the City; and

WHEREAS, the property owner desires to enter a Parklet Revocable License Agreement, and will maintain the necessary liability insurance, indemnify and hold harmless the City, and otherwise abide by the terms and conditions specified in the license agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

PARLET REVOCABLE LICENSE AGREEMENT FOR USE OF THE PUBLIC RIGHT OF WAY FOR PARKLET SIDEWALK CAFÉ AREA ADJACENT TO 2035 HOLLYWOOD BOULEVARD

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of the attached Parklet Revocable License Agreement with Go Bistro, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
