A RESOLUTION OF THE CITY COMMISSION OF THE CITY
OF HOLLYWOOD, FLORIDA, APPOINTING SIX MEMBERS
TO THE SUSTAINABILITY ADVISORY COMMITTEE.

WHEREAS, the City Commission approved Resolution R-2006-309, establishing a Green Team Advisory Committee; and

WHEREAS, the City Commission approved Resolution R-2019-318, changing the name to the Sustainability Advisory Committee ("Committee"); and

WHEREAS, the City Commission approved Resolution R-2006-361, establishing the number of members and criteria for membership on the Committee; and

WHEREAS, the City Commission approved Resolutions R-2013-090, R-2017-140, and R-2019-040, restructuring the Committee to eliminate and add positions; and

WHEREAS, the City Commission approved Resolution R- 2023-176, adding two Student Alternate Member positions; and

WHEREAS, the City Commission approved Resolution R- 2024-219, appointing the members of the Sustainability Action Committee and term durations; and

WHEREAS, the current composition of the Committee consists of a total of 15 members from the following categories: two business representatives; one South Florida Builders Association representative; eight citywide representatives, one student representative, one alternate member, and two student alternate members; and

WHEREAS, there is one vacant business member position on the Committee, due to the expiring term of Anthony Aiello, whose term expires on June 30, 2025; and

WHEREAS, there is one vacant citywide member position on the Committee, due to the expiring term of Liliana Pacelli, whose term expires on June 30, 2025; and

WHEREAS, there is one vacant citywide member position on the Committee that was not filled in 2024, whose term expires on June 30, 2027; and

WHEREAS, there is one expiring student member position due to the expiring term of Alex Manasse, whose term expires on June 30, 2025; and

WHEREAS, there are two vacant student alternate member positions that were not filled in 2024, whose terms expire on June 30, 2025; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from citizens to fill the available vacancies; and

WHEREAS, the following individuals have expressed an interest in serving on the Sustainability Advisory Committee and are eligible to fill the vacancies:
