Legislative Priorities

FEDERAL PRIORITIES:

SUPPORT

- Maintain/increase funding for CDBG and HOME programs
- Funding for programs to assist the homeless *including the Family Reunification Program*
- Funding for sewer infrastructure (septic to sewer conversions)
- Federal funding for resiliency projects to protect infrastructure (sea walls, roadways, utilities, facilities)
- Funding for beach nourishment and sand by-pass project as well as for a study to determine feasibility of using foreign offshore sand in beach nourishment projects
- Ensure property owners can obtain affordable flood insurance
- *Align zip codes to coincide with jurisdictional boundaries for mail delivery*

MONITOR

- Monitor for submission of a Land-into-Trust application by Seminole Tribe to absorb lands within the jurisdiction of the City into the reservation

STATE PRIORITIES:

SUPPORT

- Preservation of Home Rule
- Support for the return of control to local government so they may address impacts of transient rental upon single family neighborhoods
- Preservation of the ability to charge a Local Business Tax and maintenance of the current rate for Communications Services Tax
- Allow cities the authority to ban smoking on municipal property
- Amendment of state statute 327.4108 to add North and South Lakes to the list of designated anchoring limitation areas
- Funding from FIND to establish mooring fields in North and South Lakes
- Funding to assist in planning and implementing the closure of the City's ocean outfall
- Funding for planning for sea level rise and implementation of mitigation projects
- Funding and permitting of sand-by-pass project and beach nourishment
- Preservation of the local mitigation provision in the Seminole Compact
- Funding for septic to sewer conversions
- Funding from the Florida Recreation Development Assistance Program to renovate the playground at Driftwood Community Center for \$158,200
- Establish regulation of Party Houses
- Allow for the installation of public safety cameras upon Florida Department of Transportation (FDOT) rights of way to provide municipalities the ability to operate a CCTV and LPR program
- Funding for Tri-Rail Coastal Link, construction of the infrastructure needed for commuter rail as well as ongoing operational expenses
- Full funding of the Sadowski Trust to be used for housing related activities
- Continued funding for senior programming
- *Legislation that requires state agencies, water management districts, local governments, and regulated industries to consider projected sea level rise, coastal flooding and potential storm surge in all infrastructure and facility siting decisions*
- *Support the creation of a glass bottle redemption program*
- *Support the establishment of standards for communications infrastructure to mirror standards for electric utilities*
- *Support funding for street lighting upgrades in Beverly Park and Hollywood Gardens West*

EXHIBIT A

- *Support state funding of School Resource Officers (SRO) in every school*
- *Support funding toward the construction of the 441 Linear Park*

OPPOSE

- *Oppose legislation which strips local municipalities' ability to regulate frequency and length of stay for properties used as short term vacation rental*
- *Extensions on development permits granted by State law instead of by the local government*
- *Restrictions on Community Redevelopment Agencies (CRA) or reduction in authority*
- *Legislation which exempts Florida Power & Light (FPL) from paying personal property taxes*

- *Efforts to reduce local control over rights of ways and the installation of telecommunications infrastructure to implement 5G*

LOCAL PRIORITIES:

SUPPORT

- *Funding and permitting of sand-by-pass project and beach nourishment*
- *Use of Tourist Development Taxes and/or Port Everglades revenues to fund the Segment #3 renourishment and ongoing sand by-pass costs*
- *Use of Tourist Development Taxes toward expenses that promote Hollywood as a destination*
