A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED CONTRACT BETWEEN JMS CONSTRUCTION SERVICES, INC. AND THE CITY OF HOLLYWOOD IN THE AMOUNT OF \$206,983.00, FOR THE 64TH AVENUE NEIGHBORHOOD ACCESSWAY AND ROADWAY IMPROVEMENTS PROVIDED IN THE FY2014 CAPITAL IMPROVEMENT PLAN.

WHEREAS, the Seminole Tribe of Florida ("Tribe") is constructing a gated community and will be installing an eight (8) feet high privacy wall along the west side of North 64th Avenue between Charleston Street and Oak Street. This wall will restrict road connectivity to the neighborhood and The Quest School, thereby requiring the City to re-establish road access within the west half of North 64th Avenue between the proposed wall and the west properties; and

WHEREAS, In order to facilitate the project, agreements between the School Board and the Tribe were approved by the City Commission per Resolution R-2014-220; and

WHEREAS, plans and specifications for the 64th Avenue project were prepared by City staff and a Notice to Bidders was issued on September 15, 2014; and

WHEREAS, through receipt of the City's bid specifications for this project, all prospective bidders were provided with a copy of the City's contract document, including the terms and conditions contained therein; and

WHEREAS, the project was publicly advertised September 15, 2014, a Pre-Bid Meeting was held on September 26, 2014, and bid results were received on October 14, 2014 as listed below:

WHEREAS, JVA Engineering Contractors, Inc., was determined to be non-responsive because the bidder did not acknowledge all the issued addenda; and

WHEREAS, staff has reviewed all submitted bids and determined the bid received from JMS Construction Services, Inc. was the lowest responsive and responsible bid, and therefore, recommends the award of this contract for the construction of the 64th Avenue Neighborhood Accessway and Roadway Improvements to JMS Construction Services, Inc. in the amount of \$206,983.00; and

WHEREAS, funding for this project has been provided via Resolution # R-2014-301 which continued the appropriation for previously approved Capital Projects from FY2014 to FY2015; and

WHEREAS, funding is available in the Capital Account # 34.1400.14490.541.006303;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD FLORIDA:

Section 1: That it hereby approves and authorizes the execution, by the appropriate City Officials, of the attached contract between JMS Construction Services, Inc. and the City of Hollywood, together with such non material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.
