33, 34 and 35 25 th Ave	Move sidewalk from East side of 25 th Ave to West side
14 Cleveland St.	Move sidewalk to N side between Alley and Dixie Hwy.
22 Garfield St.	Move sidewalk to N side, East of 22 nd Ave.
