A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AUTHORIZATION TO PROCEED FOR WORK ORDER NUMBER ARC 23-03 WITH ARCADIS U.S., INC. FOR PROFESSIONAL ENGINEERING SUPPORT SERVICES RELATED TO LEAD AND COPPER RULE REVISION COMPLIANCE, PHASE 1, IN AN AMOUNT UP TO \$432,160.00.

WHEREAS, the Department of Public Utilities (“Department”) oversees the City’s public water system, which is regulated under the Federal Safe Drinking Water Act (“SDWA”); and

WHEREAS, the SDWA establishes protective drinking water standards for more than 90 contaminants, including Lead and Copper; and

WHEREAS, in 2021, the Environmental Protection Agency revised the existing Lead and Copper Rule (“LCRR”) to enhance monitoring, treatment, customer awareness, and lead service line replacement requirements; and

WHEREAS, the Department has determined that professional engineering support services are necessary to develop the City’s LCRR compliance strategy, create a service line material inventory, create public education materials, and provide stakeholder outreach support; and

WHEREAS, on September 20, 2017, the City Commission passed and adopted Resolution No. R-2017-283, which authorized the execution of continuing professional consulting engineering services contracts with four firms for Water Treatment Plant and Southern Regional Wastewater Treatment Plant projects, one of the firms being Arcadis U.S., Inc.; and

WHEREAS, on July 26, 2021, the continuing services contract with Arcadis U.S., Inc. was renewed for another two-year period, through November 6, 2023; and

WHEREAS, the Department requested a proposal from Arcadis U.S., Inc. to provide the aforementioned LCRR-related services; and

WHEREAS, Department staff reviewed the proposal submitted by Arcadis U.S., Inc. and negotiated the project scope and fee in an amount up to \$432,160.00, and staff determined that both the project scope and fee are fair and reasonable and in accordance with industry standards; and

WHEREAS, the Director of Public Utilities and the Chief Procurement Officer recommend that the City Commission approve and authorize appropriate City officials to execute the Authorization to Proceed for Work Order ARC 23-03 with Arcadis U.S., Inc., in an amount up to \$432,160.00 on an as-needed basis; and

WHEREAS, funding for this work order will be made available in account number 442.409904.53600.563010.001465.000.000, subject to adoption of a companion budget amendment resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of the attached Authorization to Proceed for Work Order Number ARC 23-03 with Arcadis U.S., Inc., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
