A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING ADDITIONAL SERVICES PROPOSAL NUMBERS 20, 21, AND 22 WITH O'DONNELL DANNWOLF AND PARTNERS ARCHITECTS, INC. FOR ADDITIONAL DESIGN, GEOTECHNICAL SERVICES, AND ENVIRONMENTAL SERVICES RELATED TO THE NEW POLICE HEADQUARTERS PROJECT, A GENERAL OBLIGATION BOND PROJECT, IN AN AMOUNT UP TO \$286,139.00.

WHEREAS, in a Special Election held on March 12, 2019, voters of the City approved a variety of projects to be funded by a General Obligation Bond, including the Hollywood New Police Headquarters ("Project"); and

WHEREAS, on February 19, 2020, the City Commission passed and adopted Resolution No. R-2020-047, approving the proposal with O'Donnell Dannwolf and Partners Architects, Inc. ("ODP") to provide Architectural/Engineering Services for the Project based upon the Professional Services Agreement ("Design Contract") approved by Resolution No. R-2019-222; and

WHEREAS, the New Police Headquarters concept, schematic, design development and construction documents have been completed by ODP and the Project has proceeded to the construction administration phase; and

WHEREAS, the City Manager previously approved Additional Services Proposal Numbers 1 through 6, for a total amount of \$98,420.00; and

WHEREAS, the City Commission previously approved Additional Services Proposal Number 7, for an amount of \$367,320.00 and Numbers 13, 14, 15, and 16 in an amount up to \$247,973.50; and

WHEREAS, Additional Services Proposal Numbers 8, 9, 10, and 17 were rejected by DCM staff; and

WHEREAS, Additional Services Proposal numbers 11, 12, and 18, for a total amount of \$0.00, were approved administratively; and

WHEREAS, Additional Services Proposal 19 is on hold and has not yet been submitted for approval; and

WHEREAS, at this time additional items have been identified that are required for the successful completion of the Project; and

WHEREAS, the additional items were not included in the original scope of the Project and, as a result, require additional services proposals; and

WHEREAS, several plan revisions have been requested by the City and Police Department that were not part of the original scope of the Project and, as a result, the design team has submitted Additional Services Proposal Number 20 to provide the design, plan revisions, and permitting for this additional scope for a fee of up to \$179,239.00; and

WHEREAS, the original Design Contract did not include construction administration services for the Geotechnical Engineer, and it has been determined that these services are required; and

WHEREAS, the design team submitted Additional Services Proposal Number 21 to provide these services for a total fee up to \$49,000.00; and

WHEREAS, during the course of the construction phase of the Project, it has become necessary to conduct additional soil sampling, lab tests and environmental reporting beyond what was previously anticipated, to meet the requirements imposed by Broward County, which led to the design team submitting Additional Services Proposal Number 22 to provide these services for a total fee of up to \$57,900.00; and

WHEREAS, Section 2.02A. of the Professional Services Agreement provides for additional services such as the aforementioned design services and environmental assessments that are beyond the basic services being provided for under the Project; and

WHEREAS, the Department of Design and Construction Management ("DCM") has evaluated the scope of services and negotiated the fee for Additional Services Proposal Numbers 20, 21, and 22 and have determined such fees to be fair and reasonable and in accordance with industry standards; and

WHEREAS, the Director of DCM and the Director of the Office of Procurement and Contract Compliance recommend that the City Commission approve and authorize the execution of Additional Services Proposal Numbers 20, 21, and 22 for the additional design, geotechnical and environmental services described above in an amount up to \$286,139.00; and

WHEREAS, funding for this Project was included in the amended FY 2025 Capital Improvement Plan, and is available in account numbers 333.209901.52100.531210.001190.000.000, 333.209901.52100.563010.001190.000.000, 334.179901.51900.563010.001190.000.000, 334.179901.51900.563010.001591.000.000,

334.179901.52100.563010.001190.000.000, 337.179901.51900.563010.001591.000.000; and

WHEREAS, ODP and the design team will complete the proposed professional engineering design services in approximately 18 months concurrently with the construction schedule and will not impact the overall Project schedule.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

That the foregoing "WHEREAS" clauses are ratified and confirmed Section 1: as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by appropriate City officials, of Additional Services Proposal Numbers 20, 21, and 22 with O'Donnell Dannwolf and Partners Architects, Inc., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form by the City Attorney.

That this Resolution shall be in full force and effect immediately upon Section 3: its passage and adoption.



ODP Architects has been asked to provide a proposal for additional services to the City of Hollywood Design & Construction Management, referred to as the "Client," for the project referenced above. The proposal covers the task detailed below, as well as the attached Additional Services Request from HOK.

Proposed Scope of Work

The attached proposal outlines the scope of services and associated design costs required to modify the approved Construction Documents. These modifications are in response to the owner's requests, as detailed below:

<u>Task #1 – Honor Wall Signage Consultation Services</u>

This task involves providing design assistance to review the GC and subcontractor mural suggestions. Both ODP and HOK will ensure that the suggested work aligns with the design intent for the Lobby.

Task #2— Elevator Lobby — Additional Card Readers as per RFI request #35 & RFI #144


As per RFI #35 and RFI #144, adjustments include the addition of Card Readers and the associated IT/AV work and the Elevator Lobby revisions.

Task #2a - Add a Pedestrian Gate

This task involves adding a Pedestrian Gate to one of the three entrances/exits of the property site as per the owner's request.

Task #3 – Plunge

Provide revisions to the approved and permitted 100 Construction Documents to modify the layout of the 2nd floor to include a new Plunge tub inside the Locker rooms.



Task #4 - FS Pre-action System.

These adjustments include additional work to install a pre-action system, which requires reducing the height of the property & evidence carriages to 10. Remove the Clean agent specified Server Room / Security / CID Tech Room #292 and Backup Server Room #293, as per the requests outlined in RFI #156 and Owner Directive dated 12/10/2024.

ODP/HOK/OCI Proposed Additional Work:

This is a lump sum proposal for revisions to the Contract documents to include the design of an FS Pre-action System work as described in the Proposal provided by OCI, and listed below.

Task #1 – Honor Wall Signage Consultation Services

- ODP Architects will coordinate the consultation work between HOK limited signage design consultation services, and the City and Moss teams.
 - Discuss overall strategies to design and attach the honor wall panels to the Lobby walls.
- ODP will review shop drawings or answer RFIs associated with this scope of work.
 - ODP will not provide drawings, specifications, or design details for this work.

Task #2 - Elevator Lobby - Additional Card Readers as per RFI request #35 & RFI #144

- ODP Architects will attend one (1) sub-consultant meeting with City representatives. We will
 facilitate the management of the additional scope of work related to the Elevator Lobby
 modifications, including additional Card Access controls in both the Headquarters building and
 the Parking Garage.
- ODP will track administrative items related to billing for the tasks outlined in this proposal, in accordance with HOK's ASP (attached).
- We will coordinate with stakeholders to review the additional services as detailed in this proposal.
- Internal coordination will occur within the Design Team to accommodate design options chosen by the client.
- We will provide 3D views for the PD's understanding of the space (note: these will not be rendered images).
- The proposed work includes coordination to issue an ASI update to the contractor.
- Coordination will be required for permitting revisions and approval from Agencies Having Jurisdiction, including any necessary meetings to obtain approvals.

Task #2a – Add a Pedestrian Gate

- Kick-Off Meeting:
 - ODP Architects will meet with HOK, Kimley Horn, OCI/CMAT, City, and Police stakeholders to discuss overall goals for this task in a virtual Kick-Off Meeting.



• Design Coordination:

- ODP will meet with the Design team to coordinate the Site Plan changes with HOK-Landscape, the Civil Engineer, and OCI for the man-gate.
- It is anticipated that the new man-door footing will require coordination with the Structural Engineer, who may need to size a new footing.
- o ODP will coordinate with OCI for electronic security.
- It is anticipated that the new man-door details and specifications will be included in the Architecture set and coordinated between ODP Architecture, HOK, Specs, and the Hardware sub-consultant.

ASI Update:

• The proposed work includes coordination to issue an ASI (Architect's Supplemental Instruction) update to the contractor.

• Permitting and Approvals:

- Coordination will be required for permitting revisions and approval from Agencies Having Jurisdiction, including any necessary meetings to obtain approvals.
- ODP anticipates emailing the Site Plan revisions to the Zoning Principal Planner for Administrative approval.

Task #3 – Plunge Tub

- ODP Architects will participate in one (1) sub-consultant scheduled meetings with the City representatives and will facilitate the management of the additional scope of work described in OCI's Proposal.
- ODP will keep track of administrative items related to the billing process for the tasks mentioned in this proposal and the Consultants' proposals attached.
- Coordinate with stakeholders to review the additional services for the Sauna and the Plunge.
- Internal coordination with the Design Team to accommodate the design options selected by the client.
- ODP will update the Revit Model, integrate the Plunge Tub manufacturer's recommendations into the project, and provide them to ownership for review and approval.
- The work includes coordination with the CMAR (MOSS) to include the changes on an ASI.

<u>Task 4 – FS Pre-action System as per RFI request #156</u>

- ODP Architects will attend two (2) sub-consultant meetings with City representatives.
- We will facilitate the management of the additional scope of work related to the FS Pre-action System at the following locations:
 - Evidence / Purging 136 Pre-Action Required.
 - o General Property & Evidence Vault 137 Pre-Action Required.
 - Narcotics Vault 138 Pre-Action Required.
 - o Tower Radio Room 114 -- Pre-Action Required



- Collaborate with MEPF engineers to remove from the plans the specified clean agents from the Contract Documents in the following locations:
 - o Server Room / Security / CID Tech 292 Pre-Action Not Required.
 - City Backup Server 293 Pre-Action Not Required.
- ODP will track administrative items related to billing for the tasks outlined in this proposal, in accordance with OCI/CMTA Additional Services request (attached).
- Coordination will occur within the Design Team including MEPF to accommodate changes to FS Pre-action Design:
 - Update Revit Model
 - o Update Property Evidence Elevations and callouts.
 - Update the affected spaces and coordinate material/finishes.
 - Coordinate specs updates.
- The proposed work includes coordination to issue an ASI update to the contractor.
- Coordination will be required for permitting revisions and approval from Agencies Having Jurisdiction, including any necessary meetings to obtain approvals. – Updates to the

Optional Services Allowance

Overall Optional Services Allowance:

As part of the proposal, we are allocating an Optional Services Allowance of **\$50,000.00**. This allowance is intended to cover potential costs for any unforeseen design changes or adjustments that may arise during the construction phase of the project. Such changes could be prompted by site conditions, owner requests, or changes in the scope of work. This allowance gives flexibility to accommodate necessary modifications without impacting the overall project budget.

SLS Consulting, LLC Additional Code Compliance Review:

We are also including an additional optional service for SLS Consulting, LLC to provide extra code compliance review services during the closeout phase of the project. The total allocation for this service is **\$10,000.00**. This allowance will cover the costs of addressing any comments or requirements raised by the Hollywood Building or Fire Department inspectors during the closeout review process. These comments may involve clarifications, additional documentation, or minor adjustments to ensure compliance with local building codes and safety regulations. The review services provided by SLS Consulting will help facilitate a smooth transition through the final inspection and closeout procedures.

Compensation:

ODP Architects agrees to perform the additional service tasks described below, and the owner agrees to pay an additional cost per approved option. The expected hourly rate is included.

Dear Mr. O'Donnell,

Per our discussions with the City of Hollywood, we are pleased to submit the following proposal to add a pedestrian gate at one of the vehicular gate locations. A sidewalk route to this new pedestrian gate will also be required for this work. This proposal outlines the assumptions and services HOK will provide to complete this new scope of work.

Additional Service Description:

The City of Hollywood Police Department has requested the following changes be implemented:

- Provide a pedestrian gate at one of the three vehicular gate locations on the site and provide sidewalks to this pedestrian gate.
- Amend the site plans and other landscape drawings to accommodate this new sidewalk route and pedestrian gate location.
- Coordinate these plan changes with ODP, HOK Design, the Structural Engineer, George F. Young, and the Civil Engineer, Kimley Horn.

Additional Services Assumptions and Deliverables:

These services are split into a BASE scope and an OPTIONAL scope. The City may exercise the BASE without the OPTIONAL scope, but not vice versa. The OPTIONAL scope provides additional services to the City that are anticipated by the Design Team, but not included in the BASE at the time of this proposal.

The HOK Team will provide the following:

- (BASE) HOK anticipates that ODP, HOK, and Kimley Horn will meet with City and Police stakeholders to discuss overall goals for this task in a virtual Kick-Off Meeting.
- (BASE) Based on this meeting, HOK Landscape will coordinate site plan changes with the Civil Engineer and ODP for one pedestrian gate. HOK Landscape to assess if these changes necessitate an ADA-accessible route to and from the new pedestrian gate from both sides of the security perimeter.

- It is anticipated that the new pedestrian gate footing will require coordination with the Structural Engineer, who may need to size a new footing.
- It is anticipated that ODP may need to coordinate with OCI for electronic security.
- (BASE) HOK to update the affected Landscape drawings including the overall site plans and hardscape plans to reflect the required changes.
 - It is anticipated that the new pedestrian gate details and specifications will be included in the Architecture set and coordinated between HOK Design and ODP Architecture.
- (BASE) HOK to provide new signed and sealed drawings with clouded revisions to ODP for consolidation and transmission to the City of Hollywood and Moss.
- (BASE) HOK anticipates that the City, Police, and Contractor may have minor changes and comments, so time to incorporate these minor changes has been included. Major changes to this scope of work may be subject to an additional service.
- (OPTIONAL) If an ADA-accessible route is not required by code, but desired by the City or Police Stakeholders, an additional fee will be required. This fee is included in the OPTIONAL scope fee.
- (OPTIONAL) If more than one pedestrian gate is required by the City or the Police, an additional fee will be required. This fee is included in the OPTIONAL scope fee.
- (OPTIONAL) If planting plans or planting schedules are affected, or if the new sidewalk routes necessitate the removal of trees, an additional fee will be required. This fee is included in the OPTIONAL scope fee.

Schedule:

Upon Notice-To-Proceed (NTP) for these services, the HOK Team anticipates these services will be complete in 7 weeks. The following schedule is anticipated, but will be coordinated with ODP upon approval:

- City accepts the additional services and provides NTP to the ODP|HOK Team.
- Week 1:
 - The Design Team attends a kick-off meeting with City and Police stakeholders to determine the location of the new pedestrian gate and any additional goals of this task.
- Weeks 2-3:
 - HOK Landscape coordinates the site plan changes with ODP and the Civil Engineer.
- Week 4:
 - HOK transmits new plans to ODP for inclusion in task submission to the City and Moss. It is anticipated that ODP will be responsible for consolidating all new information and transmitting the submittal to the City of Hollywood.

- Week 5-6: The City, Police and Construction Manager (CM) review the drawings and provide comments to the Design Team. HOK anticipates virtually meeting with stakeholders to discuss these comments.

CMTA has been asked to provide Electrical and Fire Suppression design for a pre-action fire suppression system for both the evidence storage area and the tower radio room.

Install a pre-action system, which requires reducing the height of the property & evidence carriages to 10'.

- a. The pipes are dry, which eliminates the accidental discharge of water from either a leaking pipe or from a sprinkler head being knocked off
- b. There is a two-stage activation requirement if a head were knocked off, this would trigger an alert in the system, but the system would not fill with water & activate unless heat were also detected.
- c. The cost is higher than the standard wet system, but less than options 2 & 3, and the system is the best design to achieve the goal of reducing the risk of accidental damage to evidence.

The reduction in height of the carriages is required because this decreases the demand for the overall system. This is needed due to the size of water main that feeds the property – a 6" main. The fire pump and generators have already been ordered, and any increase in the system beyond what is needed for 10' high carriages would impact these items as well (and at this point, we cannot change them.)


