Staff will direct the public to the designated seating area where they will be able to listen to the meeting. Once the meeting begins and maximum indoor capacity is reached, no other members of the public will be allowed in the designated seating area. The CRA Administrative Assistant will call out the names of those wishing to address the CRA Board in-person, at which time they will approach the lectern and address the CRA members. In-person participants commenting on multiple agenda items may return to the designated seating area and wait for their name to be called again.
