A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER TO STRYKER FOR THE PURCHASE OF 13 LIFEPAK 15s FOR FIRE RESCUE AND BEACH SAFETY IN THE TOTAL AMOUNT OF \$439,852.79.

WHEREAS, the Fire Rescue and Beach Safety Department requires new LIFEPAK 15s to replace their aging fleet, which is necessary to provide fire rescue services to the City; and

WHEREAS, the LIFEPAK 15 performs an electrocardiogram, monitors the electrical activity of the heart and is also a defibrillator for acute cardiac care response, designed for basic and advanced life support; and

WHEREAS, the LIFEPAK 15 should be replaced every five to seven years; and

WHEREAS, the Department has evaluated the current LIFEPAK 15 manufactured by Stryker and the two other major competitors, ZOLL and Philips; and

WHEREAS, the decision has been made that the LIFEPAK 15 manufactured by Stryker continues to meet the demands of the Department and the best option; and

WHEREAS, the LIFEPAK provided by Stryker is mostly standardized within the localities, so that if the need arises, agencies can utilize another agency's equipment without the need for training, which is critical in emergency situations; and

WHEREAS, Stryker has offered the City a discount of \$106,896.40 to replace the existing equipment; and

WHEREAS, on October 26, 2021, the Procurement Services Division posted a Notice to Sole Source Number NTSS-005-22 in Bidsync to purchase 13 LIFEPAK 15s, issued an electronic notification to various vendors, and identified November 3, 2021 as the posting expiration date; and

WHEREAS, the Procurement Services Division received no inquiries or comments on the Notice to Sole Source Number NTSS-005-22; and

WHEREAS, Section 38.41(C)(2) of the Procurement Code provides that non-competitive supplies and sole source services available from only one source such as unique, patented, franchised supplies or services are exempt from the competitive proposal requirements; and

WHEREAS, the Fire Chief and the Assistant Director of Financial Services for Procurement recommend that the City Commission approve the issuance of a purchase order to Stryker for 13 LIFEPAK 15s to replace its aging equipment for operational services in the amount of \$439,852.79; and

WHEREAS, funding for this project was included in the amended FY 2022 Capital Improvement Plan, and is available in account numbers 333.219901.52200.564530.001191.000.000 and 334.219901.52200.563010.000251.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it authorizes the issuance, by the appropriate City officials, of a purchase order to Stryker for 13 LIFEPAK 15s, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
