It's designed for basic life support and advanced life support. The LIFEPAK 15 should be replaced every five to seven years. Our fleet is approximately eleven years old. If the main electrical component fails, the LIFEPAK 15 is beyond repairable.

The proposed contract action is for product or services for which the City of Hollywood intends to negotiate and award with only one source under the authority of the City of Hollywood City Code Section 38.40 (C) (2) Sole-source supplies and services. Product and/or services to be purchased: Life-Pak 15 – EKG Machines

**Anticipated Cost**: \$439,852.79

**Sole Source Justification**: The Fire Rescue and Beach Safety Department requires new Life-Pak 15's (EKG Machines) to replace the aging fleet which is necessary to provide Fire Rescue services to the City.
