A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A PARKLET REVOCABLE LICENSE AGREEMENT WITH BAT WANG LLC FOR USE OF THE PUBLIC RIGHT-OF-WAY PARKING SPACE FOR PLACEMENT OF A PARKLET ADJACENT TO THE PROPERTY LOCATED AT 1942 HOLLYWOOD BOULEVARD.

WHEREAS, on September 5, 2018, the CRA Board passed and adopted Resolution R-CRA-2018-30, which set the rate and time frame for the Parklet Pilot Program; and

WHEREAS, the Parklet Pilot Program has expired and is no longer in place; and

WHEREAS, Barrett Windish is the owner of 1942 Hollywood Boulevard; and

WHEREAS, the property owner of 1942 Hollywood Boulevard desires to enter into a Parklet Revocable License Agreement ("License Agreement") for the installation of a Pirate Ship Parklet adjacent to their property as shown in the attached Exhibit "A"; and

WHEREAS, the property owner will maintain the necessary liability insurance and endorsements, and indemnify and hold harmless the City, and otherwise abide by the terms and conditions specified in the License Agreement; and

WHEREAS, License Agreement reflects a 12-month term and a license fee of \$8.00 per space per day.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the execution, by the appropriate City officials, of the attached Parklet Revocable License Agreements with Bat Wang, LLC, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.
