## RESOLUTION NO. R-BCRA-2023-

A RESOLUTION OF THE HOLLYWOOD, FLORIDA, COMMUNITY REDEVELOPMENT AGENCY ("CRA"), APPROVING AND AUTHORIZING THE APPROPRIATE CRA OFFICIALS TO EXECUTE A PROPERTY IMPROVEMENT PROGRAM GRANT AGREEMENT WITH JEFFERSON PROPERTY 18 LLC AND 2206 FILLMORE STREET LLC FOR ON-SITE IMPROVEMENTS TO THE PROPERTY LOCATED AT 2000 JEFFERSON STREET IN A TOTAL GRANT AMOUNT NOT TO EXCEED \$50,000.00.

WHEREAS, on February 2, 2011, the Community Redevelopment Agency ("CRA") Board passed and adopted Resolution No. R-CRA-2011-08, which amended and consolidated the Property Improvement Program ("PIP") for the Beach and Downtown Districts into one comprehensive program; and

WHEREAS, the CRA adopted the PIP to facilitate the upgrading of structures and/or eliminate slum and blighting influences within both districts of the CRA; and

WHEREAS, the PIP is a comprehensive program with eligibility guidelines and specific criteria; and

WHEREAS, Jefferson Property 18 LLC and 2206 Fillmore Street LLC ("Jefferson & Fillmore"), as a duly authorized representatives of 2000 Jefferson Street, submitted an application in accordance with the PIP requirements; and

WHEREAS, Jefferson & Fillmore intend to improve the appearance of the property located at 2000 Jefferson Street, which is within the Downtown District of the CRA; and

WHEREAS, CRA staff has reviewed the application in accordance with the PIP guidelines and has determined that the Jefferson & Fillmore application meets the eligibility criteria for a grant under the Property Improvement Program; and

WHEREAS, the total project cost for the 2000 Jefferson Street building is estimated at \$213,792.00, and the grant amount for this project will not exceed \$50,000.00, making the CRA's contribution approximately 23% of the total cost; and

WHEREAS, Jefferson & Fillmore will expend these monies on the project and the grant will be distributed upon completion of improvements; and

WHEREAS, the proposed private redevelopment will enhance and preserve the CRA's efforts for redevelopment in the area and further promote commercial redevelopment in the CRA District; and

WHEREAS, the CRA Executive Director and CRA staff recommend approval of a grant to Jefferson & Fillmore pursuant to the PIP guidelines; and

WHEREAS, after reviewing the applications submitted by Izak Ben Naim and Hanan Y. Shany on behalf of Jefferson & Fillmore, the CRA Board has found and determined that it would be beneficial to the redevelopment effort and a proper public purpose under Chapter 163, Florida Statutes, to support Jefferson & Fillmore improvement project through a grant of funds pursuant to the terms and conditions set forth in the attached property improvement grant agreement to be executed by the parties; and

WHEREAS, funding for the attached agreement have been appropriated and exists in account number 166.668602.55200.548640.000000.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the execution, by the appropriate CRA officials, of the attached Property Improvement Program Grant Agreement with Jefferson Property 18 LLC and 2206 Fillmore Street LLC, located at 2000 Jefferson Street, together with such non-material changes as may subsequently be agreed to by the CRA Executive Director and approved as to form and legal sufficiency by the CRA General Counsel.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
