A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, CONSIDERING THE CONTINUANCE/SUNSETTING OF THE FOLLOWING ADVISORY BOARDS: AFFORDABLE HOUSING ADVISORY COMMITTEE; AFRICAN AMERICAN ADVISORY COUNCIL; ARTWORK SELECTION ADVISORY COMMITTEE; EDUCATION ADVISORY COMMITTEE; GENERAL OBLIGATION BOND OVERSIGHT ADVISORY COMMITTEE; MARINE ADVISORY BOARD; PARKS, RECREATION & CULTURAL ARTS ADVISORY BOARD; SUSTAINABILITY ADVISORY COMMITTEE; AND THE YOUNG CIRCLE ARTSPARK ADVISORY BOARD.

WHEREAS, Section 37.25 of the Code of Ordinances sets forth the uniform regulations relating to City Advisory Boards, including the sunsetting and/or continuance of such boards; and

WHEREAS, pursuant to R-2022-067, the City Commission by majority vote continued the following Advisory Boards: Affordable Housing Advisory Committee; African American Advisory Council; Artwork Selection Advisory Committee; Education Committee; General Obligation Bond Oversight Advisory Committee; Marine Advisory Board; Parks, Recreation & Cultural Arts Advisory Board; Sustainability Advisory Committee; and the Young Circle ArtsPark Advisory Board; and

WHEREAS, the above referenced Advisory Boards are scheduled to be sunsetted this year and therefore must be considered by the City Commission at its March 1, 2023, meeting in order for the City Commission to determine whether to sunset such boards or by a majority vote continue the operation of such boards.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: The foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: The City Commission hereby approves the continuance or sunsetting of the following Advisory Boards as of this date:
