A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER TO CNH INDUSTRIAL AMERICA LLC FOR THE PURCHASE OF A 2023 NEW HOLLAND T6.155 EC 4 CYL STG5 AGRICULTURAL TRACTOR (#25) IN AN AMOUNT NOT TO EXCEED \$118,132.60 BASED UPON THE STATE OF FLORIDA CONTRACT #25101900-21-STC, GROUP 13, SUB-GROUP A IN ACCORDANCE WITH SECTION 38.41(C)(5) OF THE PROCUREMENT CODE (PIGGYBACK).

WHEREAS, the Department of Public Works, on behalf of the Beach Maintenance Division, requires the purchase of a 2023 New Holland T6.155 EC 4 CYL STG5 Agricultural Tractor to be utilized for the daily maintenance, cleaning and grooming of the beach; and

WHEREAS, the 2023 New Holland Agricultural Tractor was competitively bid and awarded under the State of Florida Contract Number 25101900-21-STC, Group 13, Sub-Group A on January 1, 2021, expiring on December 31, 2023; and

WHEREAS, CNH Industrial America LLC has agreed to extend to the City the same pricing under the terms and conditions set forth in State of Florida Contract Number 25101900-21-STC, Group 13, Sub-Group A; and

WHEREAS, the cost of the vehicle to be purchased is in an amount not to exceed \$118,132.60; and

WHEREAS, Section 38.41(C)(5) of the City's Procurement Code allows the Chief Procurement Officer to procure, without formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof ("piggyback"), provided that the goods, supplies, materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference and such utilization of other governmental entities contracts shall be permitted only during the term of the other governmental entity's contract; and

WHEREAS, the Director of Public Works recommends that the City Commission approve and authorize the issuance of a Purchase Order to CNH Industrial America LLC for the purchase of a 2023 New Holland T6.155 EC 4 CYL STG5 Agricultural Tractor in an amount not to exceed \$118,132.60; and

WHEREAS, a portion of the funding for the purchase was included in the amended FY 2023 Capital Improvement Plan, and is available in account number 557.519901.51900.564520.000120.000.000, and the remainder of the funding will be available in the FY 2023 Beach CRA budget in account number 163.638507.55200.564530.000000.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by the appropriate City officials, of a Purchase Order to CNH Industrial America LLC, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
