- No applications are automatically scheduled for ANY meetings. Applications must be determined to be complete by Staff before any processing occurs.
- Fees Apply to: Projects that are 20,000 gross square feet or more and is not within an industrial or single family zone.

- ☐ New residential development of two or more units built in the same tract by the same owner or developer.
- ☐ Voluntary Artwork Program: Allows preexisting development projects to propose installing artwork in public spaces, except for single family homes.
- Fees are based on a percentage of the building cost and shall be pay prior to the issuance of Building Permits.
- Fee Schedule :

- ☐ Combination of In lieu Public Art Fee and Placement of Artwork on Site: Artwork placement on the site of the development project when valued and combined with a payment of a public art fee, totals 1% of the cost of the proposed development project, which shall not be less than \$5,000.00
- Meeting Dates: As necessary. Applications shall be considered at the first PRAC meeting that is more than (30) days following staff's determination that the application is completed.

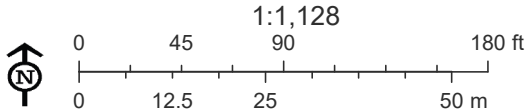

Project Summary

The Department of Parks, Recreation & Cultural Arts (PRCA), is currently seeking design proposals from artists who are interested in transforming the east facing exterior wall of the Dr. Martin Luther King Jr. Community Center with a mural. The mural's primary theme is Civic Leader, Dr. Martin Luther King Jr. in which the community center is named after as well as but not limited to representation of the Liberia Neighborhood.

The project will include a community engagement event where the community will paint a lower area of the mural design (6ft from floor) following a paint by numbers scheme, configured by artist. The selected artist or artists will design the mural and will be responsible for touching up, finish, and sealing of the mural.

Dr. Martin Luther King Jr. Community Center, 2400 Charleston Street, Hollywood, FL 33020

*Artist(s) are strongly encouraged to visit the proposed project site.

Mural Location: East Facing Exterior Wall

Mural Size: Height: 26 feet X Length: 70 feet = 1,820 square feet



Artist Eligibility: Regional

This project is open to all artists 18 years of age and older.

Entry Requirements:

1. Design elements. All designs should enhance the facilities visitor experience and include a depiction of Civic Leader, Dr. Martin Luther King Jr. as well as but not limited to representation of the Liberia Neighborhood.
2. Artist or artist team will be required to paint the design on the east facing exterior wall of the community center. Mural area may exceed twenty-five (25) feet in height and require artist(s) to utilize a lift and/or scaffolding.

3. The artwork should include a “paint by numbers” scheme located on the lower area of mural design (6ft from the floor). The purpose of which will provide an area in which the community can participate and engage in the artwork and the beautification of the facility.
4. Each artist or artist team may only submit a single application and design.

Selection Process

PRCA will review all submitted applications and present entries to the Liberia Neighborhood during a Civic Association Meeting. During said meeting, the community will vote to narrow the selection to three (3) selections. The three (3) community selections will be presented to the City Commission for review and award. All entries will be evaluated based on artistic excellence, creativity, and adherence to the entry requirements.

The solicitation resulted in 5 artist/artist groups submitting applications. On Oct 17, the City’s Art Selection Committee reviews the artist/artist group and created a short list of 3 artist experienced and qualified to move forward. The three artists where then contracted through a Performance Service Agreement (PSA) (PO’s issued) to provide a mock-up design and were paid \$300.00 ea. The mock-ups where then presented to the Liberia Community in which they ranked the designs.

April 17, 2024- City Commission will decide to approve the proposed mural design.

April 2024- East Facing Exterior Wall of Dr. Martin L. King Jr. Community Center will be prepared for the mural.

May 2024- Performance Service Agreement /Purchase Order is executed.
Project begins.
Community Engagement Paint-by-Number Event.

June 2024- Mural is completed and sealed.

Section 10. Maintenance Plan

Objective: Ensure the longevity and aesthetic appeal of the mural by implementing a comprehensive maintenance plan.

Frequency: Assess the condition of the mural bi-annually to identify any signs of wear, fading, or damage.

Materials: Use high-quality paint and weatherproofing materials to withstand the coastal environment and ensure durability.

Tasks:

- I. Bi-Annual Inspection:
 - a. Inspect the mural for any signs of damage, such as cracks, peeling, or fading.
 - b. Check for any areas where moisture may have penetrated the surface.
 - c. Evaluate the condition of the weatherproofing materials and touch up as needed.
- II. Cleaning:
 - a. Remove any dirt, debris, or bird droppings from the surface of the mural.
 - b. Use a gentle cleanser and soft brush to avoid damaging the paint.
- III. Repairs:
 - a. Address any cracks, chips, or other damage promptly to prevent further deterioration.
 - b. Touch up areas where the paint has faded or peeled using matching colors.
- IV. Reapplication of Weatherproofing:
 - a. Apply a fresh coat of weatherproofing sealant to protect the mural from moisture, UV rays, and salt air.
 - b. Ensure all edges and corners are properly sealed to prevent water ingress.
- V. Budget Allocation:
 - a. Allocate a budget of \$500 per year for maintenance expenses.
 - b. Adjust the budget as needed to ensure compliance with maintenance requirements and the longevity of the mural.

VI. Documentation:

- a. Keep records of all maintenance activities, including inspection dates, repairs made, materials used, and expenses incurred.
- b. Document any changes in the condition of the mural over time.

By following this maintenance plan, we will preserve the beauty and integrity of the mural for years to come while ensuring compliance with maintenance standards.
