WHEREAS, operational requirements necessitate certain revisions or amendments to the Adopted Fiscal Year 2015 Budget to properly align funding support for newly authorized personnel positions and adjust to personnel changes since the beginning of the fiscal year;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1:</u> That the Amendments to the Operating Budget of the City of Hollywood for the Fiscal Year beginning October 1, 2014, as set forth in detail in Exhibit 1, attached hereto, and by this reference made a part hereof, are hereby approved, adopted and accepted as Amendments to the Operating Budget of the City of Hollywood Florida, for the Fiscal Year 2015.

<u>Section 2:</u> That the Department of Financial Services is hereby authorized to establish such line item accounts as may be necessary to properly monitor and track expenditures.
