Explanation:

This Resolution seeks the approval and adoption of the City of Hollywood's proposed One Year Action Plan for the projected use of Community Development Block Grant (CDBG) and Home Investment Partnership Act (HOME) funding for the federal program fiscal year 2015 – 2016. Previously, pursuant to Resolution R-2014-229, adopted and approved on July 16, 2014, the City Commission approved a five year consolidated plan for federal program fiscal years 2014 – 2015 through 2018 – 2019. The One Year Action Plan for federal program fiscal year 2015 – 2016 sets forth the planned expenditures for fiscal year 2015 – 2016 within the federal guidelines established for the applicable funding. For federal program fiscal year 2015 – 2016, the U.S. Department of Housing and Urban Development (HUD) has allocated \$1,064,757.00 of CDBG funding and \$355,581.00 of HOME funding for City programming.
