## IE YEAR ACTION PLAN AND PROPOSED USE OF FUNDS, FISCAL YEAR 2015-2016 **COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) HOME INVESTMENT PARTNERSHIP PROGRAM (HOME)**

Pursuant to regulations set forth by the U.S. Department of Housing and Urban Development (HUD), the City of Hollywood has adopted a Five Year Consolidated Plan for Fiscal Years 2014-2015 to 2018-2019 and is in the process of developing a One Year Action Plan for Fiscal Year 2015-2016. The City anticipates receiving the following allocation to be utilized for activities that benefit low- and moderate-income persons, aid in the prevention of slum or blight, or meet community development needs having a particular urgency:
