A RESOLUTION OF THE CITY COMMISSION OF THE FLORIDA. CITY OF HOLLYWOOD. AMENDING RESOLUTION NO. R-2002-21 AND RESOLUTION NO. R-2011-206 TO REVISE THE EXISTING PLANS PROCESSING FEE AND PERMIT FEE SCHEDULE TO INCLUDE PLANS PROCESSING FEES AND PERMIT FEES FOR LANDSCAPING PLAN REVIEWS AND PLAN PROCESSING FEES FOR MAINTENANCE OF TRAFFIC PLAN REVIEWS.

WHEREAS, on July 19, 1995, the City Commission of the City of Hollywood, Florida adopted Ordinance O-95-36, which amended Chapter 151, BUILDINGS", of the Code of Ordinances to provide that building permit fees shall be established by resolution of the City Commission; and

WHEREAS, pursuant to Section 151.135, the City Commission passed and adopted Resolution No. R-2002-21, which established a permit fee schedule for building permits; and

WHEREAS, pursuant to Section 151.134, the City Commission passed and adopted Resolution No. R-2011-206, which established a plans processing fee schedule for building permits; and

WHEREAS, as part of the Department of Public Works' revenue enhancement review, staff examined the plans processing fee schedule and found that, although processing fees for the other disciplines (structural, electric, mechanical, plumbing) are being collected, review fees relating to the services that require extensive coordination provided for landscaping plans and maintenance of traffic plans are not being imposed; and

WHEREAS, as part of the Department of Public Works' revenue enhancement review, staff examined the building permit fee schedule and found that, although permit fees for the other disciplines (structural, electric, mechanical, plumbing) are being collected, review fees relating to services that require extensive coordination provided for landscaping plans are not being imposed; and

WHEREAS, the City Commission of the City of Hollywood has determined that it is in the best interest of the citizens of Hollywood to establish plans processing fees and permit fees for landscaping plans and plan processing fee for maintenance of traffic plans; NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That pursuant to Section 151.134 of the Code of Ordinances, the non-refundable plans processing fees for permits requiring a landscaping plan or maintenance of traffic plan processing on as of October September 1, 2015, shall be as follows:

Landscaping (Single-Family):	\$50
Landscaping (All others):	
1 st Hour	\$125
2 nd Hour and every hour thereafter	\$125 \$100
Maintenance of Traffic Plan Reviews:	\$50

<u>Section 2</u>: That pursuant to Section 151.135 of the Code of Ordinances, Section 6(A)(2)(c) of Resolution R-2002-021 shall be amended to include "Landscaping" on September as of October 1, 2015.

<u>Section 3</u>: That all other fees established by Resolution Nos. R-2002-21 and R-2011-206, shall remain in full force and effect.

<u>Section 4</u>: That all fees established by this and future resolutions, shall be automatically amended on each October 1, starting in 2016, by the annual increase in the Consumer Price Index for all Urban Consumers in the Miami-Fort Lauderdale Metropolitan Area as of the previous June.

<u>Section 5</u>: That this resolution shall be in full force and effect on October 1, 2015.
