A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED RIGHT-OF-WAY LICENSE AGREEMENT BETWEEN THE NATIONAL BEN GAMLA CHARTER SCHOOL FOUNDATION AND THE CITY OF HOLLYWOOD, TO UTILIZE AND MAINTAIN THE RIGHT-OF-WAY FOR A SCHOOL BUS LANE ASSOCIATED WITH THE NEW SCHOOL DEVELOPMENT LOCATED AT 2650 VAN BUREN STREET.

WHEREAS, the National Ben Gamla Charter School Foundation (the "Charter School") is the operator of the new Doral-Ben Gamla Charter School being constructed at 2650 Hollywood Boulevard, which includes an enhanced school bus lane/stop within the right of way of Van Buren Street with enhanced surfacing to further highlight and identify the bus lane/stop location; and

WHEREAS, the Charter School and the City recognize the need for entering into the attached Right-of-Way License Agreement in order to set forth the responsibilities and obligations of the Charter School to utilize and maintain the premises; and

WHEREAS, the Right-of-Way License Agreement requires the Charter School to provide and maintain liability insurance, indemnify and hold harmless the City, and otherwise abide by the terms and conditions specified in said Agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the execution by the appropriate City Officials, of the attached Right-of-Way License Agreement between National Ben Gamla Charter School Foundation and the City of Hollywood, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.
