Explanation:

This Resolution seeks authorization for the appropriate City Officials to enter into and execute a contract with Imperial Electrical, Inc. "Imperial", to rewire the existing street lights on Harrison Street from 17th Avenue East to the Intracoastal Waterway, "ICW", to correct periodic street light outages along Harrison Street. Previously, on July 16, 2014, pursuant to Resolution R-2014-224, the City Commission approved the execution of an agreement between Norman F. Bray, "Bray", and the City to provide mechanical, electrical, and plumbing engineering services to the City on an as-needed basis. Bray has provided the City with the construction documents and specifications for the rewiring and replacement of street light wiring along Harrison Street from 17th Avenue East to the ICW. Subsequently, on July 7, 2015, a Notice of Bid Availability and solicitation to qualified, interested firms was issued for the Harrison Street – Street Lighting Upgrade Project (PW 15-016). The solicitation period was closed on July 28,

2015 with one (1) firm submitting a bid response. Upon opening, reviewing, and evaluating the bid response, the bid response from Imperial was deemed to be a responsive and responsible bid and a recommendation was made to award the bid to Imperial in the amount of \$98,000.00 for the electrical services to be rendered.
