AN ORDINANCE OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING SECTION 37.01 OF THE CODE OF ORDINANCES TO COMBINE THREE DEPARTMENTS INTO ONE NEW DEPARTMENT TO BE KNOWN AS THE DEPARTMENT OF DEVELOPMENT SERVICES.

WHEREAS, the City Manager recommends combining the Departments of Community and Economic Development, Planning, and Building into a new department to be known as the Department of Development Services;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That Section 37.01 of the Code of Ordinances is hereby amended to read as follows:

TITLE III: ADMINISTRATION

* * *

CHAPTER 37: OTHER DEPARTMENTS, BOARDS, AND COMMISSIONS ADMINISTRATIVE DEPARTMENTS

§ 37.01 ADMINISTRATIVE DEPARTMENTS.

- (A) There are established the following administrative departments in the city:
 - (1) Department of Parks, Recreation and Cultural Arts;
 - (2) Department of Financial Services;
 - (3) Department of Fire-Rescue and Beach Safety;
 - (4) Police Department;
 - (5) Department of Public Utilities;
 - (6) Department of Community and Economic Development Services;
 - (7) Department of Planning;

(Coding: Words and figures <u>underscored</u> are additions to existing law; words and figures struck-through are deletions.)

- (78) Department of Public Works; and
- (8 9) Department of Information Technology; and
- (10) Building Department.

- <u>Section 2</u>: That it is the intention of the City Commission that the provisions of this ordinance shall become and be made a part of the Code of Ordinances of the City of Hollywood, Florida, and the provisions of this ordinance may be renumbered to accomplish such intention.
- <u>Section 3</u>: That if any word, phrase, clause, subsection or section of this ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of any remaining portions of this ordinance.
- <u>Section 4</u>: That all sections or parts of sections of the Code of Ordinances, all ordinances or parts of ordinances, and all resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed to the extent of such conflict.

Section 5: That this ordinance shall be in full force and effect immediately upon its passage and adoption.
