A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA APPROVING AND AUTHORIZING AMENDMENTS TO THE STATE HOUSING INITIATIVES PARTNERSHIP PROGRAM (SHIP) LOCAL HOUSING ASSISTANCE PLAN FOR STATE OF FLORIDA FISCAL YEARS 2014-2015 AND 2015-2016.

WHEREAS, Sections 420.907 through 420.9079, Florida Statutes, and Chapter 67-37 of the Florida Administrative Code (FAC), allow municipalities to receive State funds dedicated to affordable housing production and preservation; and

WHEREAS, the City of Hollywood, has established Local Housing Assistance Plans pursuant to Chapter 160, City of Hollywood Code of Ordinances; and

WHEREAS, the Local Housing Assistance Plans have been created to support housing rehabilitation, first time home ownership, acquisition, emergency repairs, disaster recovery assistance, and program administration; and

WHEREAS, on April 17, 2013, the City Commission passed and adopted Resolution No. R-2013-097 which approved the Local Housing Assistance Plan for Fiscal Years 2013/2014, 2014/2015, and 2015/2016 and included estimated program funding distribution; and

WHEREAS, the Florida Housing Finance Corporation notified the City that its actual allocation for Fiscal year 2014-2015 is \$697,452.00 and the projected allocation for Fiscal Year 2015-2016 is \$691,079.00; and

WHEREAS, in addition, for Fiscal Year 2014-12015, the City's program income is projected to be \$202,200.00; and

WHEREAS, based upon the aforementioned allocations and projections, the City's Local Housing Assistance Plan must be amended to reflect such revisions for Fiscal Year 2014-2015 and Fiscal Year 2015-2015; and

WHEREAS, each local government must use a minimum of 20 percent of its 2015-2016 allocation to serve persons with special needs as defined in Section 420.0004, Florida Statutes; and

WHEREAS, proper public notice has been provided to the citizens of Hollywood prior to the public hearing scheduled by the Hollywood City Commission;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the City hereby approves and authorizes the attached amendment to the State Housing Initiatives Partnership Local Housing Assistance Plan for Fiscal years 2014-2015 and 2015-2016 as more specifically set forth in the Housing Goals Charts attached hereto and incorporated by reference as Exhibit "A", Exhibit "B" and Exhibit "C".

<u>Section 2</u>: That the City Manager is hereby authorized to execute any and all documents related to the proposed amendment to the Local Housing Assistance Plan.

<u>Section 3</u>: That this resolution shall be in full force and effect immediately upon its passage and adoption.
