AN ORDINANCE OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING CHAPTER 99 OF THE CODE OF ORDINANCES ENTITLED "MUNICIPAL BEACH"; REVISING SECTION 99.05 SECTION (B) (1)(a) TO REFLECT REVISED OPERATING HOURS.

WHEREAS, Chapter 99 of the Code of Ordinances establishes the Municipal Beach regulations; and

WHEREAS, the City wishes to revise the 99.05 section (B) (1a) regarding the dog beach hours of operation to better accommodate users of the beach during daylight savings time; and

WHEREAS, the City Commission wishes to amend the Code of Ordinances to permit the revisions to Chapter 99;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:
