A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING THE GENERAL FUND (FUND 01) AND THE CENTRAL SERVICES FUND (FUND 57) BUDGETS OF THE FISCAL YEAR 2015 ADOPTED OPERATING BUDGET (R-2014-282), AS AMENDED, APPROVING THE TRANSFER OF CERTAIN FUNDING AND AUTHORIZING AND APPROVING THE ROLLOVER AND REAUTHORIZATION OF CERTAIN FUNDING AS DETAILED IN THE ATTACHED EXHIBIT 1; AUTHORIZING THE DEPARTMENT OF FINANCIAL SERVICES TO ESTABLISH ACCOUNTS AS MAY BE NEEDED; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, certain routine and periodic budgetary adjustments and transfers are appropriate and necessary; and

WHEREAS, the Fiscal Year 2015 Operating Budget was adopted and approved by the City Commission pursuant to Resolution R-2014-282 at the 2nd public budget hearing on September 29, 2014; and subsequently amended; and

WHEREAS, the transferring of funding between line item accounts is needed to provide funding support for the transitioning of the Code Compliance program from a Police Department program to an independent program; and

WHEREAS, the recognition, transfer and reappropriation of funding existing in certain identified accounts at the end of the 2015 fiscal year as detailed in Exhibit 1 is necessary in support of the Code Compliance program;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the Amendments to the Operating Budget of the City of Hollywood for the Fiscal Year beginning October 1, 2014, as set forth in detail in Exhibit 1, attached hereto, and by this reference made a part hereof, are hereby approved, adopted and accepted as Amendments to the Operating Budget of the City of Hollywood Florida, for the Fiscal Year 2015.

Section 2: That the Department of Financial Services is hereby authorized to establish such line item accounts as may be necessary to properly monitor and track expenditures.

RESOLUTION AMENDING THE FY 2015 OPERATING BUDGETS OF THE GENERAL FUND AND THE CENTRAL SERVICES FUND, ROLLING OVER, TRANSFERRING AND REAPPROPRIATING EXISTING FUNDING IN SUPPORT OF THE CODE COMPLIANCE PROGRAM.

Section 3: That this resolution shall be in full force and effect immediately upon its passage and adoption.
