AN ORDINANCE OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING CHAPTER 72 ENTITLED "PARKING" AMENDING SECTION 72.151 ENTITLED "AUTHORITY TO ISSUE CITATIONS" TO AUTHORIZE COMMUNITY SERVICE OFFICERS TO ISSUE CITATIONS FOR NONMOVING VIOLATIONS UNDER THIS CHAPTER; PROVIDING FOR A SEVERABILITY CLAUSE, A REPEALER PROVISION, AND AN EFFECTIVE DATE.

WHEREAS, Chapter 72 of the City of Hollywood Code of ordinances sets forth guidelines and regulations relating to parking within the City; and

WHEREAS, currently Section 72.151 authorizes Parking Enforcement Officers and Code Enforcement Officers to issue citations for nonmoving violations of Chapter 72; and

WHEREAS, in order to be consistent with the Police Department operations and to enhance the enforcement of Chapter 72, it is necessary to amend Section 72.151 to authorize Community Service Officers to issue citations of nonmoving violations if warranted;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That Section 72.151 of the Hollywood Code of Ordinances entitled "Authority to Issue Citations" is hereby amended as follows:

TITLE VII: TRAFFIC CODE

CHAPTER 72: PARKING

* * *

GENERAL PROVISIONS

§ 72.151 AUTHORITY TO ISSUE CITATIONS.

(Coding: Words in struck through type are deletions from existing law; words underscored are additions).

(A) Parking Enforcement Officers, and Code Enforcement Officers, and <u>Community Service Officers</u> are hereby authorized to issue citations for nonmoving violations of this chapter. The City Commission shall designate those nonmoving violations for which fines shall be established, and shall further specify by suitable schedules the amount of such fines, provided such fines are within the limits provided by law.

<u>Section 2</u>: That it is the intention of the City Commission that the provisions of this ordinance shall become and be made a part of the Code of Ordinances of the City of Hollywood, Florida, and the provisions of this ordinance may be renumbered to accomplish such intention.

<u>Section 3</u>: That if any word, phrase, clause, subsection or section of this ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of any remaining portions of this ordinance.

<u>Section 4</u>: That all sections or parts of sections of the Code of Ordinances, all ordinances or parts of ordinances, and all resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed to the extent of such conflict.

<u>Section 5</u>: That this ordinance shall be in full force and effect immediately upon its passage and adoption.
