A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED AGREEMENT BETWEEN GINO ITALIAN AMERICAN DELI & MEAT MARKET, INC. AND THE CITY OF HOLLYWOOD TO PROVIDE LIMITED FOOD SERVICES AT CITY HALL.

WHEREAS, the City of Hollywood requires an agreement with a qualified and experienced food services provider to provide limited food services at the snack bar area on the second floor of City Hall as the current agreement with Gino Italian American Deli & Meat Market, Inc. expired on January 6, 2016; and

WHEREAS, in 2012 the City of Hollywood issued RLI Number 4330-12-RD to seek the services of a qualified and experienced food services provider to provide limited food services at the snack bar area on the second floor of City Hall; and

WHEREAS, four (4) qualified and experienced food services providers participated in providing limited food services at City Hall on a trial basis for a period of two (2) weeks each which resulted in the final ranking of number one being awarded to Gino Italian American Deli & Meat Market, Inc. located on Johnson Street here in Hollywood; and

WHEREAS, on December 10, 2012 via Memo number PR-13-46 the City Manager authorized the appropriate City Official to negotiate and execute an agreement with the highest ranked food service provider, Gino Italian American Deli & Meat Market, Inc.; and

WHEREAS, on January 7, 2013 an agreement was awarded to Gino Italian American Deli & Meat Market, Inc. for a one (1) year period with an option to renew for two additional one (1) year periods; and

WHEREAS, on January 14, 2014, via recommendation memo PR-14-049, the City Manager approved the first renewal of the agreement for a one (1) year period; and

WHEREAS, on December 23, 2014, via recommendation memo PR-15-017, the City Manager approved the final one (1) year renewal period; and

WHEREAS; Gino Italian American Deli & Meat Market, Inc. has consistently provided quality limited food services and excellent customer service to the overall satisfaction of the City employees and City Hall visitors since opening in 2013; and

WHEREAS, the food service is an amenity for the City Employees and City Hall visitors and there is no cost to the City, and

WHEREAS, Procurement Services staff met with Mr. Gino Paparella, the owner of

Gino Italian American Deli & Meat Market, Inc., and Mr. Paparella would like to continue the business relationship with the City by providing quality limited food services at the snack bar area on the second floor of City Hall on a long term basis; and

WHEREAS, both parties are excited about a long term agreement for the City Hall snack bar area and look forward to a long and successful partnership; and

WHEREAS, the term of this Agreement shall be for an initial one (1) year period from January 6, 2016 through January 5, 2017 and may be renewed for ten (10) additional one (1) year terms upon mutual agreement of the parties; and

WHEREAS, the City reserves the right to terminate this agreement immediately with or without cause upon written notice to the Contractor, such notice will not be required to state the reason(s) for termination; and

WHEREAS, award is subject to the City receiving all insurance required and approved by the City's Risk Manager, and other terms and conditions required by the City Manager and City Attorney along with signed statements of Hold Harmless and Indemnity to the City;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the execution, by the appropriate City officials, of the attached agreement between Gino Italian American Deli & Meat Market, Inc. and the City of Hollywood for limited food services at City Hall, together with such nonmaterial changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney

<u>Section 2:</u> That this resolution shall be in full force and effect immediately upon its passage and adoption.
