WHEREAS, operational requirements necessitate certain revisions or amendments to the Adopted Fiscal Year 2016 Budget to properly align funding support for newly authorized personnel positions and adjust to personnel changes since the beginning of the fiscal year; and

WHEREAS, operational and capital requirements necessitate certain revisions to the Adopted Fiscal Year 2016 Budget to promote greater productivity, effectiveness, and efficiency;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:
