FIRST AMENDMENT TO SHIP FUNDING AGREEMENT

The provisions relating to the monitoring, enforcement, auditing, indemnification, insurance, assurances and financial responsibility shall survive the expiration or earlier termination of this Agreement as set forth in Section 12.20 of this Agreement.

- 2. That Exhibit "C" of the Agreement entitled "Timetable/Schedule For Project FY 2014/2015" is hereby amended and modified as set forth in the attached revised Exhibit "C".
- 3. All other provisions of the Agreement shall be and remain the same and in full force and effect.
