2. <u>Terms</u>. This Amendment shall be deemed a part of, but shall take precedence over and supersede any provisions to the contrary contained in the Lease. All initial capitalized terms used in this Amendment shall have the same meaning as set forth in the Lease unless otherwise provided.

3. <u>Lease Termination Date</u>. The parties hereto agree to substitute, in place of the first full sentence of Paragraph 1 of the Lease, the following language:

'The term of this Lease shall be the period from the commencement date, as hereinafter defined, through June 30, 2016, unless sooner terminated or extended as provided herein, subject to the terms and conditions of this Lease."

Except as set forth above, each provision of the Lease shall remain in full force and effect.
