A RESOLUTION OF THE CITY COMMISSION OF THE  
CITY OF HOLLYWOOD, FLORIDA, APPOINTING ELEVEN  
(11) MEMBERS TO THE GREEN TEAM ADVISORY  
COMMITTEE.

WHEREAS, the Commission passed R-2006-309 establishing a Green Team Advisory Committee; and

WHEREAS, the Commission passed R-2006-361 establishing the number of members and criteria for membership; and

WHEREAS, the Commission passed R-2013-090 restructuring the Committee to eliminate and add positions; and

WHEREAS, the current composition consists of a total of eighteen (18) members from the following categories: five (5) Hollywood Business owner/operator representatives, one (1) Environmental Group representative, one (1) South Florida Builders Association representative; and eleven (11) Citywide representatives; and

WHEREAS, the terms of two (2) members in the Business category expire on June 30, 2016, this includes the terms of Cynthia Baker and Paul Farren; and another position is vacant due to the resignation of Bob Lieberman with a term expiring on June 30, 2017; and

WHEREAS, Nakeischea Smith, a member from the Business category with a term expiring on June 30, 2017, has changed employers and no longer is eligible to represent this category, leaving this position vacant for a total of four (4) positions in the Business category available for appointment; and

WHEREAS, the position for Environmental Group Member is a vacant not filled position with a term expiring on June 30, 2018; and

WHEREAS, the category for representative of the Builders Association of South Florida (BASF) is vacant due to the resignation of Dawn Myers; and

WHEREAS, the Builders Association of South Florida (BASF) has asked that Graham Penn be appointed to represent this category; and

WHEREAS, the terms of two (2) Citywide positions expire on June 30, 2016; one is vacant due to the resignation of Dawn Fuller, the other is occupied by Monique Damiano; and

WHEREAS, one (1) Citywide position is vacant with a term expiring on June 30, 2017 due to the resignation of Eric Schreiber and one (1) Citywide position with a term expiring June 30, 2018 is vacant due to the resignation of Thomas Krakauer; and

WHEREAS, one (1) Citywide position with a term expiring June 30, 2017 will become vacant with the proposed appointment of Graham Penn to the Builders Association of South Florida position; and

WHEREAS, since Nakeishea Smith's original term does not expire until June 30, 2017, the Committee Liaison recommends that Ms. Smith fill the position being vacated by Graham Penn; and

WHEREAS, a total of five (5) Citywide positions are available for appointment; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from citizens to fill the available vacancies; and

WHEREAS, the following individuals have expressed an interest in serving on the Green Team Advisory Committee and are qualified to fill the vacancies:
