A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPOINTING SEVEN (7) MEMBERS TO THE AFRICAN AMERICAN ADVISORY COUNCIL.

WHEREAS, the City of Hollywood African American Advisory Council was created in 1993 to act as a liaison between the African American community and the City; and

WHEREAS, Resolution No. R-93-352 established the African American Advisory Council, Resolution No. R-94-106 established the board's criteria and Resolution No. R-97-116 increased the membership to twelve; and

WHEREAS, the City Commission passed and adopted Resolution No. R-2005-293, which increased the membership of the African American Advisory Council (AAAC) from twelve (12) to thirteen (13), and two (2) alternate positions were created; and

WHEREAS, the City Commission passed and adopted Resolution No. R-2011-333, which increased the number of alternate positions from two (2) to three (3); and

WHEREAS, the current AAAC now consists of 13 members and three (3) alternates; and

WHEREAS, members must reside or work in the City of Hollywood, be of African American descent, and/or have extensive knowledge and interest in the African American community; and

WHEREAS, AAAC members Fern Canter, Carolina Forbes, David Nichols and Emmanuel Okwar have resigned and the remainder of their terms which expire on June 30, 2017 must be filled; and

WHEREAS, AAAC members Taj Dixon and Dawn Fuller have resigned and the remainder of their terms which expire on June 30, 2018 must be filled; and

WHEREAS, AAAC has one (1) alternate member vacancy due to the resignation of Edward Polonio whose term expires on June 30, 2017; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from citizens to fill available vacancies; and
