WHEREAS, currently the following members terms expire on June 30, 2016: (1) Visual Arts Field, Beverly Lewis-Fifield; (1) Performing Arts Field, Larry Perez; (2) Citizen-At-Large- Hollywood Residents, Maurice Gosby and Freddy Suasteguiu; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from the community to fill the current vacancies; and

WHEREAS, the following individuals have expressed their interest in being appointed to, or becoming new members of the Young Circle ArtsPark Advisory Board:
