

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE THE ATTACHED BLANKET PURCHASE ORDER BETWEEN PEOPLE'S CHOICE PRESSURE AND THE CITY OF HOLLYWOOD FOR PRESSURE CLEANING SERVICES, FOR AN ESTIMATED ANNUAL EXPENDITURE OF \$62,100.00.

WHEREAS, the Department Public Works requested that Procurement Services solicit bids for Pressure Cleaning Services for various locations throughout the City; and

WHEREAS, Notifications of Bid F-4390-14-RD were mailed on November 5, 2013, and the bid was advertised online via the City's website and DemandStar on November 5, 2013, in accordance with the City's Purchasing Ordinance, Section 38.42(A)(1); and

WHEREAS, Bid F-4390-14-RD was opened at 3:00 P.M. on December 6, 2013, and resulted in responses from eleven (11) bidders:

WHEREAS, Mold Finders and Sunshine Cleaning Systems Inc. were deemed non-responsive as they did not provide current Maintenance of Traffic (M.O.T.) Intermediate Certifications as required in the bid document; and

WHEREAS, People's Choice Pressure Cleaning is the overall lowest, responsive, responsible bidder; and

WHEREAS, after all Bids received were reviewed, the Director of Public Works and the Director of Procurement Services have recommended that the City Commission approve the award of the bid and authorize the issuance of the attached blanket purchase order to the overall lowest responsive, responsible bidder, People's Choice Pressure Cleaning of Davie/Hollywood, Florida, for an estimated annual expenditure of \$62,100.00; and

WHEREAS, the initial term is for a three (3) year period with the right to renew for two (2) additional one (1) year periods subject to vendor(s) acceptance, satisfactory performance and the determination that renewal will be in the best interest of the City; and

WHEREAS, the award is subject to the City receiving all insurance required and approved by the City's Risk Manager, along with signed statements of Hold Harmless and Indemnity to the City; and

WHEREAS, funding has been provided in the fiscal year 2014 budget in the Capital Improvement – Maintenance Account Number 63.0185.00180.552.004637 and the Maintenance – Buildings Account Number 01.5174.00000.519.004635, and will be budgeted in subsequent fiscal years;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the issuance, by the appropriate City Officials, of the attached blanket purchase order between People's Choice Pressure Cleaning and the City of Hollywood, together with such non material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.

Section 2: That this resolution shall be in full force and effect immediately upon its passage and adoption.
