This Resolution seeks authorization for the appropriate City Officials to issue the attached blanket purchase orders to the three (3) authorized local Goodyear dealers

and increase annual expenditures \$86,600.00 to a combined total of \$188,600.00 for the initial year of the contract and increase the estimated annual combined total to \$223,600.00 for the second year of the two (2) year contract. The initial contract term began May 20, 2015 and continues through May 19, 2017 with two (2) additional one (1) year renewal options.

The City of Hollywood is piggybacking through the Florida Sheriffs Association Bid Award Number 15/17-07-0220 as per the City of Hollywood Purchasing Ordinance Section 38.40 (C) (5) allows procurement without formal procedures, all goods and services which are subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, public officers, or any combination thereof, provided however, the goods and services are: (i) the subject of a price schedule negotiated by the state or the United States government, or (ii) the subject of a contract with another governmental entity or corporation not for profit whose members are governmental entities, public officers, or any combination thereof, which is based strictly on competitive bids or competitive proposals and not any preference.

The Resolution transfers in Exhibit 1 decrease account number 57.5101.00109.590.005211 – Motor Fuel/Oil by \$80,000.00 and increase account number 57.5101.00109.590.005212 – Automotive Supplies \$80,000.00. Exhibit 1 also decreases account number 57.5101.00105.590.005211 – Motor Fuel/Oil by \$30,000.00 and increases account number 57.5101.00102.590.005212 – Automotive Supplies by \$30,000.00.

Funding is available in Public Works Fleet Management Division account numbers 57.5101.00102.590.005212 – Automotive Supplies, 57.5101.00109.590.005212 – Automotive Supplies, and Fire Rescue & Beach Safety Department's account number 01.2151.00000.522.005212 – Automotive Supplies and will be budgeted in subsequent fiscal years subject to the passage and adoption of each subsequent fiscal year's Operating Budget by the City Commission.
