Requests for Proposals (RFP) Number 4503-16-RD was electronically advertised via BidSync in accordance with the City's Purchasing Ordinance, Section 38.42(A) March 15, 2016, and opened April 12, 2016 with three (3) responses. On April 27, 2016 the three (3) proposals were evaluated by the three (3) member evaluation committee representing the Department of Public Works and the Office of Public Affairs and Marketing and declared responsive and responsible.
